CONDUCT OF EXAMINATION FOR GROUP C PARAMEDICAL POSTS

The Examination for recruitment to Group C Paramedial Posts is scheduled to be held on <u>10th December, 2023</u> (Sunday).

The link to download Call Letter for appearing in Examination for Group C Paramedical Posts along with Information Handout are uploaded on the website of ESIC (https://www.esic.gov.in/recruitments).

As per Govt. of India, Ministry of Social Justice & Empowerment OM F. No. 34-02/2015-DD-III, dated: 29th August, 2018 - <u>"the candidate should have the discretion of opting for his own scribe/reader/lab assistant or request the Examination Body for the same."</u>

As per above O.M. dated: 29th August, 2018 in case the candidate is allowed to bring his/her own scribe, the qualification of the Scribe should be one step below the qualification of the candidate taking examination.

In case it is found that the qualification of the Scribe brought by the candidate is not one step below the qualification of the candidate taking examination, the candidature of the candidate shall be summarily rejected.

Accordingly, PWD candidates appearing in the above examination are advised that in case they need the assistance of Scribe, they have the discretion of (1) Opting for their Own Scribe or (2) they can make a request (through email/telephone/written application/personal visit) to the ESIC Regional Office of the State in which their Exam. Centre is situated for providing Scribe by <u>07.12.2023</u>.

Candidates can also make a request via email/telephone at <u>jd-rectt@esic.nic.in/Tel. No. 011-23219513</u> for providing Scribe <u>by 07.12.2023</u>.

- 2. In case it is found that the qualification of the Scribe brought by the candidate is not one step below the qualification of the candidate taking examination, the candidature of the candidate shall be summarily rejected. In such case the candidate shall forfeit his/her right to the post and claims relating thereto.
- 3. The candidate is **blind/low vision** or affected by **cerebral palsy** with **loco-motor impairment and his/her writing speed is affected** and she/he needs a writer (scribe) as permissible under the Government of India rules governing the recruitment of Physically Challenged persons.
- 4. As per the rules, the candidate availing services of a scribe is eligible for compensatory time of 20 minutes for every hour of the examination.
- 5. In view of the importance of the time element and the examination being of a competitive nature, the candidate undertakes to fully satisfy the Medical Officer of the Organization that there was necessity for use of a scribe as his/her writing speed is affected by the disabilities mentioned in Point 3 above.
- 6. The candidate has ensured that the scribe is not a candidate for the same recruitment exercise.
- 7. The scribe has ensured that he/she is not appearing in the same recruitment exercise.
- 8. All the above statements made by us are true and correct to the best of our knowledge and belief. We also understand that in case it is detected at any stage of recruitment that we do not fulfill the eligibility norms and/or that the information furnished by us is incorrect/false or that we have suppressed any material fact(s), the candidature of the applicant (both the candidate as well as scribe in case he/she has appeared in the same examination) will stand cancelled, irrespective of the result of the examination. If any of these shortcoming(s) is/are detected even after the candidate's appointment, his/her services are liable to be terminated.
