Banking & Finance

1. IFSCA becomes associate member of global lobby group International Organization of Securities Commissions(IOSCO)

Membership will provide IFSCA (regulator of financial institutions at IFSC) the platform to exchange information & learn from best practices of the regulators of other well established financial centres. IOSCO brings together world's securities regulators. GIFT IFSC: 1st international financial services centre in India.

2. RBI launches Digital Payments Index(DPI) to capture extent of digitisation of payments; DPI grew 2x in March 2020 v March 2018.

RBI-DPI has 5 broad parameters: Payment Enablers, Payment Infrastructure – Demand-side factors, Payment Infrastructure –Supply-side factors, Payment Performance and Consumer Centricity; March 2018 is the base period, with a DPI score of 100. DPI for March 2019 & March 2020 work out to 153.47 & 207.84.

3. RBI makes Legal Entity Identifier mandatory for large-value transactions in RTGS/NEFT from April

Mandatory LEI system for all payment transactions of value ₹50 crore & above undertaken by entities (non-individuals) using RBI-run Centralised Payment Systems. LEI is a 20-digit number used to uniquely identify parties to financial transactions worldwide. In India, it can be obtained from LEI Ltd, subsidiary of CCIL

4. RBI unveils guidelines for Payments Infrastructure Development Fund (PIDF) scheme to boost digital payments

An advisory council (AC) under RBI deputy governor BP Kanungo has been constituted for managing the fund. It will be operational for 3 years effective from January 1, 2021 & may be extended for 2 more years. Fund has a corpus of ₹345 crore. Fund aims to create payment points in Tier-3 to Tier-6 centres

5. CMS Info Systems to set up 3,000 ATMs for SBI by March; to invest Rs 200 crore

The outsourced model or Brown Level ATM (BLA) is managed by the service provider on behalf of bank. Most of these ATMs are offsite ATMs. CMS provides end-to-end ATM management service. Rs 200 crore will be for setting up & hire 2000 employees for managing. CMS Info Systems President Manjunath Rao

6. SMCB: First Urban Cooperative Bank in India to receive a commercial banking license under voluntary transition scheme

Shivalik Small Finance Bank (SSFB) will start its banking operations from April 2021. It has received the commercial banking license from banking regulator Reserve Bank of India (RBI). 22 year old Shivalik is the first & largest multi-state UCB in UP. SMCB: MD&CEO:Suveer Kumar Gupta; HQ:Saharanpur,UP

7. Bandhan Bank signs MoU with Indian Army to provide banking services to Army personnel

Bandhan Bank Shaurya Salary Account will have zero balance facility with 6% interest on balance above Rs.1 Lakh, unlimited free ATM transactions, waiver of issuance &annual charge on Shaurya Visa Platinum Debit Card, offers protection for self & assets etc. Bandhan Bank: MD & CEO:Chandra Shekhar Ghosh; HQ:Kolkata

8. RBI fully operationalised College of Supervisors to strengthen supervision

CoS will have a full-time Director supported by a 6 member Academic Advisory Council (AAC). N S Vishwanathan is the chairperson to the council.Rabi Narayan Mishra is the director.CoS was functioning in a limited way in virtual mode since May 2020.

9. IDFC Mutual Fund unveils new pan India campaign #PaisonKoRokoMat,Investor Awareness initiative

IDFC Mutual aims to shift the conversation regarding wealth creation from the traditional to the contemporary.Urges savers to overcome their inertia and become investors by exploring



the smart and modern mutual fund vehicle for their investments.IDFC Mutual is managed by IDFC AMC; CEO & MD: Vishal Kapoor

10. RBI to conduct Variable Rate Reverse Repo auction on Jan 15 for notified amount of Rs 2 lakh crores

In order to restore normal liquidity management operations in a phased manner, RBI to conduct variable rate reverse repo auction of Rs 2 lakh crore on Jan 15. Repo rate is the rate of interest rate at which the central bank lends short term money to banks. Usual duration of variable-rate term repo is 7, 14 & 28 days.

11. RBI cancels the licence of Osmanabad's Vasantdada Nagari Sahakari Bank; 99% depositors to get full deposits back

Continuance of bank is prejudicial to the interests of its depositors & it would be unable to pay its present depositors in full. It is now prohibited from conducting business of 'banking' as defined in Section 5(b) read with Section 56 of BRA,1949. Every depositor will get deposits up to Rs.5 lakh from DICGC.

12. NSE launches futures & options contracts for Nifty Financial Services index, third index which has its own equity derivatives.

Index consists of 20 stocks & is designed to reflect behaviour & performance of Indian financial market, which includes banks, financial institutions, etc. This is the 1st time that the exchange has made available weekly futures for stock index derivatives. Currently NSE offers only Nifty 50 & Nifty Bank Index.

13. RBI's 22nd Financial Stability Report: Banks gross NPA may rise to 22 years high of 13.5% by September 2021

Report reflects an assessment of Sub-Committee of the Financial Stability and Development Council on risks to financial stability in country.CRAR of SCBs improved to 15.8% in Sep 2020 from 14.7% in March 2020;GNPA ratio declined to 7.5% from 8.4%. Under severe stress scenario,GNPA ratio may escalate to 14.8%

14. RBI slaps ₹2 crore fine on Deutsche Bank AG for breach of norms on deposit rates

Non-compliance with certain provisions of directions issued by RBI contained in RBI (Interest Rate on Deposits) Directions, 2016. Penalty imposed under provisions of Section 47 A(1)(c) read with Section 46 (4)(i) of Banking Regulation Act,1949. Deutsche Bank AG/India: HQ:Mumbai; CEO:Kaushik Shaparia

15. IDFC First Bank enters credit card business with lowest finance charges of 9% on revolving credit for eligible cardholders.

Interest of 36% annually (40% by other lenders) on revolving credit & nil interest on cash withdrawal for first 45 days. But cardholders will have to pay a nominal fee of Rs 250 per cash withdrawal against Rs.500 charged by others. IDFC First Bank: MD&CEO:V.Vaidyanathan; HQ:Mumbai.

16. IIFL Finance, Standard Chartered enter into co-lending partnership

Fairfax & CDC-backed IIFL Finance's wholly-owned subsidiary IIFL Home Finance Ltd & SCB co-lending arrangement is for extending MSME loans.Under Co-Lending Model(CLM) scheme banks can provide loans along with NBFCs to priority sector borrowers. IIFL Finance is retail-oriented NBFC with 90% loan under retail.

17. Axis Bank launches 'Aura'- a credit card exclusively loaded with affordable health and wellness solutions

Aimed at health conscious individuals, these features will be powered by Poshvine and other specialists such as Decathlon, Practo(4 free online consult/month), Fitternity, IndushealthPlus, 1MG etc., to offer a complete and unique health & wellness solution. Axis Bank: CEO:Amitabh Chaudhry; HQ:Mumbai.



18. YES Bank launches new initiative for MSMEs, offers Rs 5 crore loan without collateral to startups

Offers: linkages to over 700 industry associations via YES BizConnect;YES Spark offers collateral-free funding up to Rs.5 crore;advisory & wealth management solutions;easy borrowing channels; insurance products;sweep-in facility etc. 5 elements of proposition:borrow,save,simplify,partner & protect

19. 2020 'Too big to fail' list: SBI, ICICI Bank, HDFC Bank remain as domestic systemically important banks (D-SIBs)

According to analysts, too big to fail is a phrase used to describe a bank or company that's so entwined in the economy that its failure would be catastrophic.D-SIB framework requires RBI to disclose names of banks designated as D-SIBs from 2015. D-SIBs have additional CET1 requirement. It is 0.6% for SBI.

20. In its first, ICICI Bank launches 'InstaFX' mobile app to help customers obtain Forex Prepaid Card swiftly

The InstaFX app enables the authorised money changers, who are partners of the Bank, to complete the KYC verification and validation of customers digitally and on a real-time basis.'ICICI Bank Forex Prepaid Card' gets activated swiftly within a few hours. ICICI is first in India to offer such facility to money changers

21. Bajaj Finance to enter payment solutions market with Bajaj Pay

'Bajaj Pay' will be an integrated payment platform comprising of UPI, PPI, EMI card and credit card options & will be launched in the fourth quarter of FY21.Would also be launching 'Bajaj Pay for Merchants' app, which will cater to over 100,000 merchants. Bajaj Finance: HQ:Pune; CEO:Sanjiv Bajaj

22. Mastercard launches one-stop resource site to support digital transformation of SMEs in Asia Pacific

As COVID-19 drives a rapid and lasting shift to e-commerce & contactless payments, the onestop center features guides on digital transformation, e-learning courses, information about Mastercard products and services for SMEs, cyber security insights etc. Microsite: Digital Acceleration for Small Businesses

23. NSE remains world's largest derivatives exchange for 2nd consecutive year in 2020.

According to Futures Industry Association, NSE was largest in terms of number of contracts traded. It was also fourth in the world in cash equities by number of trades by the World Federation of Exchanges (WFE) for calendar year 2020. Vikram Limaye is MD & CEO of NSE

24. Airtel Payments Bank introduces Safe Pay to curb online frauds

When customers transact through UPI or net-banking using Airtel Payments Bank, Airtel Safe Pay is an additional wall that will prevent online frauds. 25. RBI imposes Rs 2 crore monetary penalty on Standard Chartered Bank

This pertains to directions contained in frauds classification and reporting rule by commercial banks.Penalty imposed under provisions of Section 47A(1)(c) read with Section 46 (4)(i) of the Banking Regulation Act for delays in reporting of frauds to RBI. SCB India: HQ: Mumbai; CEO:Zarin Daruwala

26. RBI proposes 4-tier structure for tighter regulation of NBFCs

In its discussion paper on revised regulatory framework for NBFCs, the RBI has said the regulatory and supervisory framework of NBFCs should be based on a four-layered structure: Base Layer, Middle Layer, Upper Layer and a possible Top Layer NBFCs are licensed under Section 45 IA of RBI Act, 1934



27. UAE central bank slaps over Rs 13 cr monetary sanction on Bank of Baroda for violating anti-money laundering law.

The monetary sanction on Bank of Baroda, GCC Operations, Dubai for deficiencies in compliance of Federal Decree Law of 2018 on Anti Money Laundering and Combating the Financing of Terrorism and Financing of Illegal Organisations. Bank of Baroda GCC Operations CEO is Ananda Kumar.

28. HSBC inaugurates International Banking Unit(IBU) at GIFT City near Gandhinagar, Gujarat.

HSBC is one of earliest global financial institutions setting up a branch at GIFT City and first bank to get a licence from the newly set up International Financial Services Centres Authority (IFSCA).UK based HSBC has been present in India for 160 years. HSBC Bank India: CEO:Surendra Rosha; HQ:Mumbai.

29. Repco Bank bags three awards at the Frontiers In Cooperative Banking Awards (FCBA) 2020.

Repco Bank renders services to rehab & upliftment of repatriates from Burma and Sri Lanka. The awards include women leader of the year award for Repco Bank MD RS Isabella, Best Digital Bank Award, and Best Fraud Control Initiative among co-operative banks. Repco Headquarters T. Nagar, Chennai. Founded in 1969.

30. RBI extends Rs 7,000-crore special liquidity assistance to DBS Bank

Funds will be used by DBS Bank India to meet its short-term funding needs after the acquisition of Lakshmi Vilas Bank (LVB). This funding may be charged with interest rates close to or linked to the repo rate, at which the RBI usually lends to banks. DBS Bank India: CEO:Surojit Shome; HQ:Mumbai.

31. RBI cancels licence of Kolhapur-based Shivam Sahakari Bank

Licence of Maharashtra-based Shivam Sahakari Bank has been canceled by the RBI as it does not have adequate capital and earning prospects. With cancellation of licence the process of paying the depositors as per the DICGC Act, 1961 will be set in motion. Each depositor in bank is insured upto a maximum of Rs. 5,00,000





Economy

1. Govt extends benefit of RoDTEP scheme(tax refund scheme) to all export goods from Jan 1,2021 to boost export

It will now refund to exporters embedded central, state & local duties or taxes that were not being rebated or refunded.Rates would be based on G K Pillai committee recommendation. RoDTEP launched in 2020 was expected to be limited to 3 sectors initially. RoDTEP replaced MEIS scheme that was not WTO compliant.

2. FSSAI's new policy limits trans fats to 2% in all oils & fats by Jan 2022

Food Safety and Standards Authority of Indiaannounced that all edible refined oils, vanaspati, bakery shortening, margarines, vegetable fat spreads and mixed fat spreads may only contain 3% or less trans fats by Jan 2021 & 2% or less by Jan 2022. Partially hydrogenated vegetable oils(PHVOs) source of trans fat

3. Bajaj Auto now world's most valuable two-wheeler brand: Crosses Rs 1 lakh crore market cap mark

It became the first two-wheeler company globally to cross a market capitalisation of Rs 1 lakh crore (around USD 13.6 billion). Bajaj Auto has achieved this milestone as it celebrates the 75th year of its operations Baja Auto: HQ - Pune; Chairman - Rahul Bajaj; Founded - 1945.

4. Madhya Pradesh & Andhra Pradesh rewarded for completing three out of four citizen centric reforms.

Financial assistance of ₹1,004 crore given by Fin Min under Scheme of "Special Assistance to States for Capital Expenditure" as they completed the One Nation, One Ration Card Reforms, Ease of Doing Business Reforms, and Urban Local Bodies Reforms. Power Sector Reform is the other reform.

5. India's 2020-21 GDP seen contracting 7.7%: Govt's first advance estimate by National Statistical Office (NSO)

Contraction from a growth rate of 4.2% in 2019-20 mainly due to Covid-19 impact. Contraction in almost all sectors except agri & electricity generation.Advance estimates of GDP are released before Union Budget & aids in budget-making process. Agri & elec gen growth rate estimated at 3.4% & 2.7%.

6. Indian economy to rebound with 8.9% growth in fiscal 2022: IHS Markit

According to IHS Markit, Indian economy is likely to rebound with 8.9% growth in the FY beginning Apr '21. The National Statistical Organisation predicted that the economy would contract 7.7% in the current FY. Economy suffered a severe contraction in 2020 HIS Markit CEO: Lance Uggla. HQ: London, UK.

7. Indian Railways to operate trains at speed of 130 Kmph along the Golden Quadrilateral and Golden Diagonal sections

1,280 km length out of 1,612 Km in GQ-GD route enhanced. This covers the entire GQ-GD route over South Central Railway, except Vijayawada - Duvvada section, where signaling upgradation work is in progress. GQ-GD connects 4 major metros Delhi, Kolkata, Mumbai & Chennai.

8. India's GDP to record 10.1% expansion year-on-year in FY22, monetary policy to be neutra from accommodative in August 2021: ICRA

FY22's value of GDP will only mildly surpass the 2019-20 level. It also sees inflation exceeding the mid-point of MPC's medium target of 4% for third consecutive year. ICRA pegged the GDP fall at 7.8% this financial year. ICRA: HQ: Gurugram; CEO:N.Sivaraman.

9. Kyrgyzstan election: Sadyr Japarov wins presidency with landslide

The Central Election Commission said Mr Japarov had won 79% of votes cast. He was serving as acting prime minister of Kyrgyzstan in the interim government following the resignation of Sooronbay Jeenbekov amidst electoral protests. Kyrgyzstan: Capital:Bishkek; Currency:Kyrgyzstani som



10. Kerala becomes 8th State to complete ease of doing business reforms;Additional borrowing permission of Rs. 2,373 crore granted

Reform includes completion of first assessment of 'District Level Business Reform Action Plan', elimination of various requirements by businesses & implementation of computerized central random inspection system. 8 States have been granted Rs.23149 crore. Kerala: CM:Pinarayi Vijayan; Governor:Arif Mohammad Khan.

11. Digit Insurance becomes first start-up to enter the unicorn club in 2021 with \$1.9 billion valuation

Digit is an insurance start-up, founded with the aim of making insurance simple. It has a portfolio of products across motor, travel, property and health insurance. The insurer uses technology to simplify processes for their customers. It is a part of the sandbox initiative of IRDA

12. India's forex reserves up by \$758 million to lifetime high of \$586.082 billion

foreign currency assets (FCAs), a major component of the overall reserves, rose by \$150 million to \$541.791 billion. The country's reserve position with the IMF rose by \$35 million to \$5.181 billion. The gold reserves climbed by \$568 million to \$37.594 bn. Special drawing rights with the IMF increased by \$5M to \$1.515Bn

13. General Motors To Invest C\$1 Billion In Canada Plant To Manufacture Electric Vans

General Motors Co & labor union Unifor have reached a tentative deal for the automaker to invest nearly C\$1 billion (\$785.42 million) in its CAMI Assembly Plant in Ingersoll, Ontario, to manufacture commercial electric vans(EV600). Capital: Ottawa; Currency: Canadian Dollar; PM:Justin Trudeau

14. PM announces Startup India Seed Fund Scheme of Rs 1000 cr for startups

The government will launch a Rs 1,000-crore seed fund for startups called Startup India Seed Fund will help startups with the initial capital for growth and operations. The new seed fund for startups comes after the Ministry of Electronics&Information. Union minister of MeitY-Ravi Shankar Prasad

15. CARE lowers Centre's fiscal deficit projection to 7.8% of GDP

CARE Ratings has revised downwards its projection of the Centre's fiscal deficit to 7.8 % of GDP during FY21 against its earlier estimate of 9-9.5 %. Combined effect of lower revenues & higher expenditure is likely to push the fiscal deficit to 7.8% of GDP Care Ratings HQ: Mumbai; CEO:Ajay Mahajan

16. FM Nirmala Sitharaman launches the Union Budget Mobile App as India gears up for first paperless budget

The government has launched the app for all Budget 2021-related documents that will be made available after the Finance Minister's speech on February 1, to provide easy & hasslefree access to all Budget 2021-related information, documents Article 112 prescribes for Annual Financial Statement

17. Overseas investment by Indian companies dips 42% to \$1.45 billion in December: RBI data

In the year-ago period, companies in India had invested \$2.51 billion in their foreign firms (joint ventures / wholly-owned units). In November 2020, the total outward foreign direct investment (OFDI) was \$1.06 billion, down by 27% from a month-ago period. \$775.41 million was in the form of equity infusion.

18. Centre releases 2nd basic grants instalment of Rs 12,351 crore to 18 states for Rural Local Bodies(RLBs).

Grants are released as per recommendations of 15th Finance Commission. It recommended two types of grants basic and tied -to the RLBs. First instalment of basic grants worth Rs. 18199 was released in June 2020 & tied grants worth Rs. 15187.50 as well. States should transfer this to RLBs within 10 working days.



19. India to become Fastest Growing Economy in next 2-years as per IMF

While presenting the Economic Survey 2021, Chief Economic Adviser Krishnamurthy Subramanian stated that India will become the fastest growing economy in the world in the next two years as per the International Monetary Fund. India is to have Current Account Surplus of 2% of GDP in FY 2021

20. India's real GDP to record a 11 per cent growth in Financial Year 2021-22: Economic Survey

The Economic Survey tabled in the Parliament projects India's real GDP to record a 11 per cent growth in Financial Year 2021-22 and nominal GDP to grow by 15.4 per cent, the highest since independence, as nation is witnessing a V-Shaped Economic Recovery. V-shaped recovery is characterized by quick & sustained recovery

21. National Statistical Office released 1st Revised Estimates of National Income, Consumption Exp, Saving & Capital Formation

NSO has released 1st Revised Estimates(RE) for FY 2019-20 along with 2nd RE for FY 2018-19. Nominal GDP- estimated at ₹203.51 lakh cr for 2019-20; ₹188.87 lakh cr for 2018-19. Real GDP - ₹145.69 lakh cr for 2019-20; ₹140.03 lakh for 2018-19. GNI = GDP + Net primary income from ROW (Receipts less payments).





National

1. PM reviews projects worth over Rs 1 lakh crore in 34th PRAGATI meeting.

Programmes and grievances pertaining to UP, MP, Rajasthan, J & K, West Bengal, Maharashtra, Delhi, Haryana, Gujarat and Dadra and Nagar Haveli and two centrepiece government programmes - Ayushman Bharat and Jal Jeevan Mission were reviewed. PRAGATI - Pro-Active Governance and Timely Implementation.

2. Union Home Minister Shri Amit Shah released inaugural issue of "National Police K-9 Journal"

First such publication in the country on the subject of Police Service K9s (PSKs) i.e. Police Dogs.It is a step in creating an ecosystem in the country to train & learn on augmenting this vital resource.The biannual journal will be released in April & Oct. A special 'Police K9 Cell' was established in November 2019.

3. IOC launches India's first Remote Monitoring & Operation Centre for Tracking of Indian Oil's Refinery Gas Turbines

Set up in Hyderabad by BHEL-GE Gas Turbine Services (BGGTS), a joint venture of BHEL and General Electric. It will analyse operational data from 27 gas turbines at 8 Indian Oil Corporation refineries across the country. IOC chairman S.M.Vaidya

4. TRIFED initiates Marketing & Logistics intervention for promoting products of North – Eastern region

TRIFED under Ministry of tribal Affairs has formulated a proposal in which it will collaborate with Ministry of Development of North Eastern Region (DoNER) & India Post to implement a successful marketing and logistic intervention for promoting the NER. Tribal Co-operative Marketing Federation of India formed in 1987

5. Ministry of Ports, Shipping & Waterways starts Sagarmala Seaplane Services (SSPS) project with potential airline operators.

Started under a Special Purpose Vehicle(SPV) framework, which will be implemented & executed through Sagarmala Development Company Ltd.It will be initiated on select routes, including Delhi, Mumbai & Surat. Services will soon begin at Yamuna riverfront. Seaplane service in operation bt Kevadia & Sabarmati riverfront.

6. Denmark's Oscar nominee 'Another Round' to be opening movie at 51st International Film Festival of India in Goa.

Thomas Vinterberg's Another Round, starring Mads Mikkelsen, will be the opening film at 51st IFFI.It will close with India Premier of historical drama 'Wife of a Spy' by Kiyoshi Kurosawa, who bagged Silver Lion for Best director at Venice film festival. The festival will also mark world premier of "Mehrunisa"

7. Ramesh Pokhariyal, Smriti Irani launch 'Toycathon 2021' to promote manufacturing of indigenous toys

Conceptualize new & innovative toys using local material which are economical, affordable, safe & environment friendly;2 categories: for online toys & another for physical toys.Students & faculty members participating can get reward up to Rs.50 lakhs. Toy market in India is \$1 bn but India imports 80% of toys.

8. Boris Johnson cancels Republic Day visit to India over COVID-19 crisis in U.K.

It is cancelled in view of the pandemic which has escalated in UK because of the new variant of coronavirus. An invitation to be Republic Day chief guest is symbolic from the Indian government's perspective. UK was chosen for ties post-Brexit. Johnson would have been the 6th leader from UK to be Chief Guest

9. Indigenously designed ballastless tracks to be used for high-speed RRTS trains

National Capital Region Transport Corporation will use these tracks for India's first Regional Rapid Transit System (RRTS). Will be suitable for high-speed trains(up to 180 kmph) ; require



low maintenance.To be first used on 17 km Sahibabad-Duhai section. India''s first RRTS corridor between Delhi and Meerut.

10. Argentine filmmaker Pablo Cesar to head 51st IFFI's International jury

Known for his contribution to African cinema with films like:Equinox, the Garden of the Roses, Los dioses de agua&Aphrodite,the Garden of the Perfumes.Other jury members:Sri Lanka's Prasanna,Austria's Abu Bakr, Bangladesh''s Rubaiyat Hossain & Priyadarshan IFFI will be held from January 16 to January 24.

11. Bureau of Indian Standards celebrated the 74th foundation day.



1. Colonel Narendra 'Bull' Kumar, who helped secure Siachen for India, passes away at 87

The ace mountaineer was instrumental in launching Operation Meghdoot & securing Siachen Glacier in 1984. He mapped the area in 1981-82. Awarded Padma Shri(1965), Param Vishisht Seva Medal , Kirti Chakra, Ati Vishisht Seva Medal & Mac Gregor Medal .

He was 1st Indian to climb Mt. Nanda Devi

2. Legendary Odia Music Director Shantanu Mohapatra Passes Away At The Age Of 84

He has over 1900 compositions, which include 53 films, 60 dramas by All India Radio(Cuttack), 10 Jatras & 10 dance dramas. Holds credit for many firsts in Odia music: modern lullaby in AIR, qawali,bhangra tune, fusion and jumping note. Won 80 awards and accolades, highest as an Odia Music Director.

3. Former Union minister and Congress leader Buta Singh passes away at 86.

The eight-time parliamentarian was first elected in 1962 from Moga Lok Sabha constituency, Punjab. He was Deputy minister of railways in 1974, Chairperson of the Organising Committee for Asian Games in 1981 & Union home minister under Rajiv Gandhi. He was chairman of NCSC from 2007-2010.

4. New Zealand Test Great John Fulton Reid Dies of Cancer at The Age of 64

Reid, who made his Test debut against Pakistan in 1979, represented Black Caps in 19 Tests & 25 ODIs. Playing between 1979 and 1986, finished his Test career with a noteworthy average of 46.28, which included six hundreds. His conversion rate of centuries from half-centuries was 75%.

5. Olympic bronze and World Cup winning hockey player Michael Kindo passes away

He played 3 Men's Hockey World Cup in 1971,1973 & 1975 where India bagged bronze, silver & gold medals. He also represented in 1972 Olympic Games where India secured a bronze medal. Kindo received the Arjuna Award in 1972. India beat Pakistan in 1975 & won the lone World Cup.

6. Former Maharashtra minister Vilas Patil Undalkar passes away at 82

Veteran Congressman, Undalkar,7 time MLA from Karad-South Assembly representing it for a record 35 consecutive years(1980-2014) passed away. Affectionately known as 'Vilaskaka', held Cooperation and Law and Justice portfolios in erstwhile State Cabinets. Prithviraj Chavan represents that constituency now.

7. Mali ex-PM Modibo Keita Dies Aged 78

Keita served as prime minister from 2015 to 2017. Modibo Keita was one of six prime ministers to serve under President Ibrahim Boubacar Keita, who was ousted in a coup in August. Initially a teacher, Modibo Keita went on to hold numerous posts.

Mali: Capital: Bamako; Currency: West African CFA franc.

8. Poet and lyricist Anil Panachooran passes away at 55

A lawyer by profession, Anil came into limelight in 2007 with much appreciated songs in Arabikkadha. Famous poems include Anaadhan (about a mentally challenged woman who gives birth to a baby on the street), Valayil Veena Kilikal, Pranayakalam etc. Jimikki Kammal was one of his most viral film songs.

9. World's oldest living first-class cricketer Alan Burgess of New Zealand passes away at 100

Right-hand batsman & left-arm spinner, he played 11 first-class matches for Canterbury between 1940-41 & 1951-52 out of 14 first-class games overall, scoring 466 runs and picking up 16 wickets. Also a World War II veteran.

Now Raghunath Chandorkar is oldest living 1st class cricketer.



10. Indian fashion designer Satya Paul passes away

Satya Paul, the Indian fashion designer who invented modern sari, has died. He revolutionised the idea of sari for Indian women, moving it beyond a utilitarian ethos. He also pioneered the "trouser sari". The label diversified into other products as well. The first sari boutique in India - L'Affaire.

11. Former Gujarat CM Madhavsinh Solanki passes away

Senior Congress leader Madhavsinh Solanki who served as former Chief Minister of Gujarat & External Affairs Minister from June 1991 to March 1992 passed away. He had been the longest-serving chief minister of the state before Narendra Modi became the CM. Gujarat Incumbent CM: Vijay Rupani.

12. Netaji Subhas Chandra Bose's niece Chitra Ghosh passes away

Chitra Ghosh, the youngest daughter of Sarat Chandra Bose and niece of Netaji Subhas Chandra Bose, passed away. Ghosh was a professor of Social and Political History, at the Netaji Institute for Asian Studies in Kolkata. She has also authored many books. Sarat Chandra Bose was a barrister & independence activist.

13. Congress leader K K Ramachandran Master passes away

Popularly known as Ramachandran Master, the Congress leader had represented the party as an MLA six times – three times from Kalpetta and thrice from Sultan Bathery Assembly constituency. He was secretary of Kozhikode District Congress Committee. He was Min for Food & Civil Supplies in the A K Antony Ministry.

14. Pulitzer Prize-winning author & journalist Neil Sheehan dies at 84

His account of the Vietnam War, A Bright Shining Lie: John Paul Vann and America in Vietnam, took him 15 years to write. The 1988 book won the Pulitzer Prize for non-fiction. He broke the story of the Pentagon Papers for The New York Times(NYT) The coverage won NYT the Pulitzer Prize for public service, 1972.

15. Padma Awardee journalist Turlapati Kutumba Rao passes away at 89.

Veteran journalist, writer & Padma Shri awardee(2002), worked as editor & editorial writer of Telugu newspaper Andhra Jyothi for close to three-and-a-half decades; addressed a record number of public meetings, which earned him a slot in the Guinness Book. He was personal secretary to Tanguturi Prakasam 1st CM of Andhra

16. Renowned writer Ved Mehta, who took India to Americans, dies at 86

The Indian-American novelist, overcame blindness & was widely known as the 20th-century writer most responsible for introducing American readers to India."Daddyji" was first installment in a 12-volume series of autobiographical works, "Continents of Exile." Mehta's 24 books included volumes of reportage on India

17. Legendary Australian tennis coach Bob Brett passes away at 67.

He worked with Grand Slam champions like Johan Kriek,Boris Becker, Goran Ivanisevic & Marin Cilic. Brett received the ATP's Tim Gullickson Career Coach award in November 2020. He also coached for national tennis associations in Britain, Japan and Canada.

He adhered to Harry Hopman's coaching philosophy

18. Renowned astrophysicist Professor Shashikumar Madhusudan Chitre passes away at 84

A recipient of Padma Bhushan, he retired as a senior professor from TIFR in Mumbai in 2001. His scientific research is focused on solar physics, astrophysics & gravitational lensing. He was a stalwart of Indian astronomy community, particularly solar physics. He was former president of the Astronomical Society of India.

19. Sheldon Adelson, the billionaire mogul who built a casino empire, dies at 87.

He built a casino empire spanning from Las Vegas to China and became a singular force in domestic and international politics. Chairman & CEO Las Vegas Sands Corporation foresaw correctly that Asia would be an even bigger market. In 2018, Forbes ranked him No.15 in the U.S., worth \$35.5 billion



20. Sahitya Akademi winning Tamil writer A Madhavan passes away at 87.

He won Sahitya Akademi in 2015 for his collection of short stories, Ilakkiya Chuvadukal that captured stories & struggles of people in Thiruvananthapuram's Chalai market. Novel Punalum Manalum was translated into English as On A River's Bank. He won Vishnupuram award in 2010.

21. Agricultural Machinery Pioneer Helmut Claas of CLAAS group (a global agricultural machinery manufacturer) Passes Away at 94

In 2013 he was made a member of American Equipment Manufacturers 'Hall of Fame'.In 2009,made a knight of the French Legion of Honour, the highest honour given by French government.Under him,Renault Agriculture in France was acquired.

22. Sir Brian Urquhart, legendary UN troubleshooter, dies at 101

The Brit joined UN in 1945 & until his retirement in 1986, he worked as a principal adviser to five UN secretaries-general, directed 13 peacekeeping operations, recruited 10,000 troops from 23 countries & instituted peacekeeping as a core tenet of UN.

His autobiography: A Life in Peace and War

23. Noted social activist and Padma Shri awardee D. Prakash Rao passes away in Odisha at 63

He was known for his contribution towards imparting education to slum and orphan children in Cuttack.He worked as a tea seller ever since he was 6 years & shot to fame after he set up a school(Asha Ashvaasan) to help educate 70 slum-dwelling children.

24. Udayan Bose, pioneer of investment banking in India, dies at 71

Known for his networking skills and relationships with some of the biggest names of Corporate India, Bose led the Indian arm of Lazard. He brought modern investment banking and venture capital to India in 80s & set up second private Indian mutual fund.

Bose started his career with Grindlays Bank.

25. Former MP and vice-president of Tamil Maanila Congress BS Gnanadesikan (71) passes away

He was being treated for an age-related illness.Gnanadesikan was a staunch follower of Congress leader and former Tamil Nadu Chief Minister K Kamaraj.From 2011-2014, he served as the president of TNCC.Gnanadesikan was elected to the Rajya Sabha in twice. TN CM: Edappadi K. Palaniswami; Governor:Banwarilal Purohit

26. Ustad Ghulam Mustafa Khan, legendary Hindustani classical vocalist and Padma Vibhushan awardee, passes away aged 89

Awarded Padma Shri in 1991,Padma Bhushan in 2006 & Padma Vibhushan in 2018 & Sangeet Natak Akademi award in 2003. His grandfather Ustad Inayat Husain Khan is credited as founder of Rampur-Sahaswan gharana of music. Sangeet Natak: highest Indian recognition to practicing artistes.

27. Banking heir Benjamin de Rothschild dies at 57

Benjamin de Rothschild was chairman since 1997 of the banking empire Edmond de Rothschild Group started by his father in 1953. He is descendent of the Rothschild family, which has a nearly 300-year history running European banks. Edmond de Rothschild Group manages assets worth 160 bn euros.

28. Cancer Institute's veteran oncologist V Shanta passes away in Chennai at 93.

V. Shanta was doyen of cancer care in the country & chairperson of the Adyar Cancer Institute.Was awarded Padma Shri (1986) & Padma Bhushan (2006) for her efforts towards making quality & affordable cancer treatment accessible to all.

Was also awarded Padma Vibhushan & the Ramon Magsaysay awards.



29. Former union minister Kamal Morarka dies at 74

More popular for his humorous roles, he debuted with a sombre role in Jayaraj's Deshadanam in 1996. Was hugely popular for his role as Thekkedathu Gopalakrishnan in Kalyanaraman. He debuted at the age of 73.

31. Former Arunachal Governor Mata Prasad passes away at 95

36. Noted physician from Telangana Ramaka Lakshmana Murthy better known as people's doctor , passes away

Lakshmana Murthy was a close associate of People's Poet Kaloji Narayana Rao from whom he imbibed the spirit of social service. After serving 2 decades at MGM Hospital, Warangal, he set up his own clinic at Ramnagar, Hanamkonda to give free treatment to poor. Praja Kavi Kaloji Narayana Rao was conferred Padma Bhushan, 1992.

37. Former India goalkeeper Prasanta Dora passes away at 45

Prasanta made his national debut in 1999 against Thailand in the Olympic qualifiers. He donned the national colours again in tournaments like SAFF Cup and SAF Games and earned a total of five international caps.

Represented Bengal in the Santosh Trophy. He played for East Bengal, Mohun Bagan and Mohammedan Sporting.

38. Ex-Pond's India chief Venkateswaraayyar Narayanan passes away

He served as the chairman & MD of Pond's India Ltd, which became part of Hindustan Lever Ltd(HLL), and served on the board of HLL.An alumnus of Lawrence School at Lovedale &



Loyola College, he began his career in 1959 as a management trainee in HLL (now HUL) He served with Pond's (India) till 1997.

39. Patna-based renowned social scientist, economist Shaibal Gupta passes away

He was known as an institution builder & he considered the establishment of Asia Development Research Institute as his most important achievement. His contribution to development economics and development challenges of Bihar had received wide attention. Made contributions as member of State Finance Commission as well

40. David Washbrook, a leading historian of colonial South India, passed away in London

Born in Mirpur, now in Pakistan-Occupied Kashmir, was an elected member of the first Constituent Assembly of Jammu and Kashmir formulated in 1951 and finalised the separate constitution of J&K.He represented the Nowshera Assembly segment.

He was a stalwart of the Quit Kashmir movement.

42. Oscar winning-actor Cloris Leachman dies at the age of 94

Won best supporting actress Oscar for The Last Picture Show in 1971. She played a lonely wife. She is also known for her comedic delight as the fearsome Frau Blücher in Young Frankenstein and self-absorbed neighbor Phyllis on The Mary Tyler Moore Show. Leachman won eight Emmy Awards in her storied television career

43. Nagaland Chief Secretary Temjen Toy passes away

Environment

1. India to be co-chair of Asia Protected Areas Partnership (APAP), a regional forum to conserve wildlife habitats, for 3 years.

APAP chaired by IUCN Asia & co-chaired by an APAP member country. It currently has 21 members from 17 countries. It helps govts & other stakeholders to collaborate for more effective management of Protected Areas. India is replacing South Korea as co-chair. APAP launched at IUCN World Parks Congress in Australia in 2014.

2. United Nations' FAO names 4 Asian tea cultivation sites as Globally Important Agriculture Heritage Systems

Chosen sites are: Pu'er Traditional Tea Agrosystem & Jasmine tea site(China), Traditional Tree Grass system(Japan)& Fuzhou and Traditional Hadong Tea Agrosystem (South Korea).India has 3 sites: Koraput traditional agri, Kuttanad farming, Saffron heritage. GIAHS was started in 2002 by FAO.

3. Centre's draft notification declares Eco Sensitive Zone(ESZ) around Mathikettan Shola National Park,Kerala.

One kilometre (17.5 square kilometre) area around the Park declared as ESZ.Restrictions on construction activities, area cannot be transferred for commercial or industrial use & eco tourism projects must be prepared according to the zonal master plan. Neutrino project site is falling outside this ESZ now.

4. Joint study group surveillance squad formed to check toxic pollutant level in Yamuna

Concerned over the issue of increasing ammoniacal nitrogen, in the Yamuna, CPCB formed a study group to monitor the ammonia levels. A joint surveillance squad comprising officials from relevant dept of Delhi & Haryana was also formed. CPCB(1974): Chairman: Shiv Das Meena; HQ: New Delhi.

5. Centre Approves Advisory For Management Of Human-Wildlife Conflict

Standing Committee of National Board of Wildlife(SC-NBWL) approved it. The advisory makes important prescriptions for the States/ UTs for dealing with Human-Wildlife conflict situations & seeks expedited inter-departmental coordinated & effective actions. NBWL constituted under Section 5A Wildlife (Protection)Act, 1972.

6. Caracal put on critically endangered list

National Board for Wildlife approved a recovery program for Caracal, a medium sized wild cat, which is now critically endangered species found only in Gujarat & Rajasthan. There are now 22 species on critically endangered species recovery programme. NBWL, advisory body chaired by PM; Constituted in 2003.

7. Javadekar releases Management Effectiveness Evaluation (MEE) of 146 National Park and Wildlife Sanctuaries

India has a network of 903 Protected Areas in covering about 5% of the total geographic area. In order to assess the efficacy of Protected Areas, evaluation of management effectiveness is required.MEE score of 62.01% which is higher than global mean of 56% MEE of Indian Zoos framework was also released.

8. A new species of fruit fly named after Siruvani, an ecological hotspot in Western Ghats

The fruit fly 'Euphranta siruvani' belonging to family Tephritidae was identified by researchers from a non-forest area in Coimbatore,TN near Siruvani.104 known species from genus Euphranta are distributed across the world, of which 14 are found in India. It has a distinct V-shaped black band on its forewing.

10. Sunderbans home to 428 species of birds, records ZSI's "Birds of the Sundarban Biosphere Reserve"

Sunderbans, covers 4,200 sq km, is part of the largest mangrove forest in the world & also a world heritage site & a Ramsar Site. India has 1300 bird species. 428 birds include Masked Finfoot and Buffy fish owl which are recorded only from the Sunderbans. 9 out of 12 species of kingfishers in India are found here.

11. National Marine Turtle Action Plan launched.

Considering the need to have a conservation paradigm for marine megafauna and marine turtles, the Ministry of Environment Forest and Climate Change (MoEF&CC) released 'Marine Mega Fauna Stranding Guidelines' and 'National Marine Turtle Action Plan'. Contains actions that are required to handle stranded animals.

1. India sets up South Asia Group for Energy(SAGE), a high level group, under Ram Vinay Shahi for South Asia energy security.

Objective is to achieve a balanced & optimal development of energy infrastructure through mutual understanding & cooperation.Cross-border energy trade is a key part of Prime Minister's neighbourhood-first policy, with plans to build energy links. Set up under MEA run think tank RIS.

2. Centre decides to form committee to protect language, culture & land of Ladakh

Union Budget 2021-22 Highlights

FM Nirmala Sitharaman in her Union Budget 2021-22 speech in the parliament announced FDI limit in insurance to be increased to 74% from now existing 49%. Govt has allowed foreign ownership in insurance with safeguards.

The govt will also launch a Securities Market Code which will include SEBI Act, Govt Sec act, Depositories Act. SEBI will be notified as regulator for a gold exchange. FM said that the govt is proposing to strategically divest 2 PSU banks and 1 general insurance company.

FM Nirmala Sitharaman has also announced measures under Aatmanirbhar Package. She said the early PM garib Kalyan Yojana amounted to almost presenting 5 "mini budgets" in 2020. She proposed strengthening of 'Sankalp of Aatmanirbhar Bharat'. Focus on 6 pillars, which include – **Health & Well-being, Inclusive Development, Human Capital, Innovation and R&D**. FM added that the govt is fully prepared to support and facilitate economic growth and they are introducing Aatmanirbhar Swastha Bharat Yojana with an outlay of Rs 64,180 crore.

FM announced that Jal Jeevan Mission Urban will be launched with and outlay of **₹ 2.87 lakh crore** over 5 years which is aimed at universal water supply in all 4,378 urban local bodies, with 2.86 crore household tap connections and liquid waste management in 500 AMRUT cities. She also announced Urban Swachh Bharat Mission 2.0 with outlay of **₹** 1,41,678 crore over 5 years from 2021 focused on complete fecal sludge management, waste water treatment, source segregation, management of waste from urban construction, bioremediation of legacy dump sites.

Announcing major infrastructure boost, FM announced highway works in various states including 3,500 km corridor in Tamil Nadu, 1,100 km in Kerala at investment of Rs 65,000 crore, 675 km in West Bengal at a cost of Rs 95,000 crore and 1,300 km in Assam in the next 3 years. In May 2020, Govt announced the Atmanirbhar Bharat package, to sustain the recovery further we also rolled out two more Atmanirbhar packages. Total financial impact of all packages including measures taken by <u>RBI</u> was estimated to be about Rs 27.1 lakh crores, Sitharaman added.

For Railways Budget, the FM announced that <u>Indian Railways</u> will have a **National Rail Plan** for upto 2030. For aviation sector, FM said that the next lot of airports will be privatized in tier 2 and 3 towns and cities. FM said that in FY22 outlay (budget estimate) for health & well-being is up 138%, and is at Rs 2,23,846 crore. Govt has also allocated Rs 35,400 crore towards COVID vaccines for FY22 and is committed to more if required. She said Modi govt is committed to achieving targets laid out under the national infrastructure pipeline. Ujjwala scheme will be expanded to over 1 crore more beneficiaries. We will add 100 more districts in the next three years to the city gas distribution network. A gas pipeline project will be taken up in Jammu and Kashmir, FM said.
