

Banking & Finance

1. RBI Enhances Rules for Banks' Grievance Redress Mechanisms

Framework effective from Jan 27,enhances disclosures on complaints,to provide insight on volume & nature,time taken,mechanism for ombudsman to recover cost of redressal from banks whose complaints exceed their peer group average,review by RBI etc. Banking Ombudsman Scheme was introduced in 1995.

2. Federal Bank launches 'FedFirst' savings account scheme for children(both resident and NRIs) up to 18 years

The account will enable children to learn importance of money management. Account holder is provided with a FedFirst contactless Debit Card with daily cash withdrawal limit of Rs 2,500 & POS/eCom limit of Rs.10000 & access to net banking, mobile/mail alerts. Federal Bank: MD&CEO: Shyam Srinivasan; HQ: Aluva, Kerala.

3. Reserve Bank of India projects GDP at 10.5 percent in 2021-22

The RBI monetary policy review has decided to maintain the status quo on key policy rates. GDP growth is projected at 10.5% in FY 2021-22 and the projection of CPI inflation has been revised to 5.2% for the fourth quarter of the current financial year. Repo Rate- 4%; Reverse Repo Rate- 3.35%; Bank Rate - 4.25%.

4. RBI has announced certain measures of protection including a 24x7 helpline for digital payment services

RBI has announced certain measures for common bank account holders. It includes setting up of 24*7 helpline for digital payment services, integrated ombudsman scheme, CTS across all bank branches & allowing retail investors to open Gilt accounts with RBI. Integrated Ombudsman Scheme will be rolled out in June 2021.

5. ICICI Bank signs MoU with Japan's MUFG Bank

ICICI Bank signed an MoU with MUFG Bank, Japan's premier bank, for collaboration towards catering to the banking requirements of Japanese corporates present in India. MUFG Bank is the largest bank in Japan headquartered in Tokyo. CEO: Kanetsugu Mike. ICICI Bank CEO: Sandeep Bakhshi HQ: Mumbai

6. RBI releases Annual Report of Ombudsman Schemes, 2019-20

According to the report, there was an increase of nearly 65% in the receipt of complaints under the 3 Ombudsman Schemes of RBI in 2019-20, & a disposal rate of over 92% was achieved. In 2019-20, a total of 330543 complaints were received under the schemes. Banking Ombudsman Scheme was introduced in 1995.

7. Bank of Maharashtra ties up with LoanTap Credit for co-lending to MSMEs

Bank of Maharashtra entered into a co-lending agreement with the Pune-based non-banking financial company LoanTap Credit Products, for MSME loans. Under this, the bank will have an exposure of up to 80 per cent while the rest will be borne by the LoanTap. MD & CEO of Maharashtra: A. S. Rajeev. HQ: Pune.

8. RBI observes Financial Literacy Week 2021: February 8 to February 12

The RBI observes Financial Literacy Week 2021 (FLW 2021) between February 8 and 12. RBI has been observing FLW annually since 2016. The theme for FLW 2021 is 'Credit Disclipne and Credit From Formal Institutions'. It was launched by Ajay Kumar. Reserve Bank of India is headquartered in Mumbai, Maharashtra.

9. PNB inks deal with Indian Oil to provide up to Rs 2 cr loan to dealers

PNB inked a pact with Indian Oil Corp to provide up to Rs 2 crore to the oil company's dealers. It will benefit dealers with credit facilities at lower interest rates, nil margin, & with minimum/zero collateral requirements through PNB e-Dealer scheme. IOCL Chairman: S M Vaidya HQ: New Delhi



10. BRICS' New Development Bank commits \$100 mn to NIIF Fund of Funds

NDB committed \$100 million to India's National Investment and Infrastructure Fund's (NIIF) Fund of Funds. Envisioned in the Union budget 2015, NIIF was launched as an alternative investment fund in December 2016 with a target corpus of '40,000 crore. In August, NIIF's FoF received investment from the ADB.

11. RBI restricts withdrawals from Nashik based Independence Co-operative Bank

RBI in exercise of its powers under Section 35A of Banking Regulation Act, 1949, put restrictions on withdrawals from Independence Co-op Bank Limited because of its present liquidity position. However, 99.89% of the depositors are covered by DICGC scheme. The restrictions will remain in force for a period of 6 months.

12. SIDBI, COWE launch campaign to promote Stand-Up India scheme

SIDBI, along with the Confederation of Women Entrepreneurs of India, launched a campaign to give a fillip to the government's Stand Up India scheme. The mega campaign - Swavalamban Sashakt is a 20 webinar series aimed at creating awareness about SUI scheme The scheme has now been extended up to FY2025.

13. AGS Transact and Mastercard partner to give India's first-ever 'Contactless' Cash Withdrawals on ATMs

Mastercard cardholders will be able to withdraw cash by scanning a QR code displayed on ATM screen of all participating banks using their banking app on phone. Involves 4 steps: open app, scan QR code, authenticate amount by entering mPIN and pick-up cash. Mastercard: Executive Chairman: Ajay Banga; HQ: New York, US.

14. RBI tightens norms for investments in NBFCs from non-FATF nations

According to the new rules, fresh investors from jurisdictions which feature in FATF's list of high risk countries or those placed under monitoring should hold less than the threshold of 20% of the voting power in an NBFC. It is to stop money laundering. There are 17 such non-compliant FATF nations at present.

15. HDFC Bank invites startups and solo entrepreneurs to apply for SmartUp grants under its CSR brand Parivartan.

The initiative is aimed at finding and deploying long-term, sustainable solutions at scale, to address social issues and contribute to economic and social development of the country. Start-ups in edtech & skill development sector will be focused this year. Bank has partnered with 9 start-up incubators for the same.

16. CREDAI, IPPB ink pact to open bank accounts for construction workers

Realty developers' body, Confederation of Real Estate Developers' Associations of India signed MoU with Indian Payments & Postal Bank to facilitate opening of bank accounts for construction workers. It is aimed at ensuring financial literacy among them. CEO of IPPB: J. Venkatramu CEO of CREDAI: Pramod K Gupta

17. RBI forms expert panel to explore consolidation of urban co-op banks

RBI constituted an 8-member expert panel to draw up a regulatory road map for urban cooperative banks (UCBs) and study the sector's consolidation prospects. The committee will suggest effective measures for faster rehabilitation and resolution of UCBs. Head of the committee: Former Dy Gov of RBI N S Viswanathan.

18. Bank credit growth at 90% of FY20 level: RBI

According to the Reserve Bank of India's data on Scheduled Banks' Statement of Position in India Bank credit growth in FY21, as of January 29 reached about 90% of the year-ago level. Year-to-date (YTD) credit growth of all scheduled banks: '3,39,147 crore. YTD credit growth a year ago: '3,74,938 crore.

19. Asian Development Bank to provide Rs 100 crore loan to Medanta to combat COVID-19

Asian Development Bank (ADB) to provide Rs 100 crore loan to hospital chain Medanta for healthcare services and medical equipment to fight the COVID-19 pandemic. It will support



the purchase of personal protective equipment, ventilators, beds, etc., It will also support staff training programmes.

20. RBI issues directions for housing finance companies

RBI came out with a slew of directions related to maintenance of liquidity coverage ratio, risk management, asset classification and loan-to-value ratio, among others, for housing finance companies. These directions came into force with immediate effect. HFC is a form of Non-Banking Financial Company.

21. RBI permits residents to make remittances to IFSCs under LRS

RBI permitted resident individuals to make remittances under the Liberalised Remittance Scheme to International Financial Services Centres in India under the Special Economic Zone Act, 2005. It is aimed at deepening the financial markets in the IFSCs. India's first IFSC: Gujarat International Finance Tec-City.

22. Google partners with European Investment Fund to invest \$75 million in coronavirus-hit small businesses

Google partnered with European Investment Fund & two other organisations in Latin America and Asia to provide \$75 million in funding to small &medium sized co., suffering from impact of pandemic. The funds are part of \$800 mn initiative announced last year EIF is the lending arm of the European Union.

23. Indian Bank signs MoU with SID of IISc, for funding Start-ups and MSMEs

State-owned Indian Bank signed an MoU with Society for Innovation and Development (SID), an initiative of Indian Institute of Science, for extending exclusive credit facilities to Start-ups & MSMEs. It is a part of Ind Spring Board for financing Start-ups. Indian Bank CEO: Padmaja Chundru HO: Chennai

24. Bank of Maharashtra partners with Vayana Network to offer help MSMEs

BoM entered into a strategic partnership with Vayana Network to offer financial support to MSME sector. Through this association BoM will provide short term credit to meet funding requirements of dealers of corporates via Mahabank Channel Financing Scheme. BoM HQ: Pune CEO: A S Rajeev

25. RBI puts Rs 1,000 withdrawal cap on Deccan Urban Cooperative Bank

RBI imposed a withdrawal cap of Rs 1000 on customers of Deccan Urban Cooperative Bank & barred the lender from granting fresh loans or accepting deposits. The bank cannot undertake any fresh business, including giving new loans and taking fresh deposits. 99.58% of the depositors are fully covered by the DICGC.

26. RBI ropes in Punjabi rapper Viruss for awareness campaign on cyber fraud

The RBI has been running the campaign 'RBI Kehta Hai' on social media accounts since 2016 but has never been accompanied with peppy music. The campaign also includes Viruss' popular 2017 Indie hit 'Bam Bhole'. 'RBI Kehta Hai', was launched in 14 languages.

27. ICICI Bank partners with Greater Chennai Corporation and Chennai Smart City Limited to launch 'Namma Chennai Smart Card'

ICICI Bank announced the launch of a Common Payment Card System (CPCS) in partnership with the Greater Chennai Corporation (GCC) and Chennai Smart City Limited (CSCL) to provide citizens a one-stop solution for making various kind of payments. Tamil Nadu Chief Minister K. Palaniswami.

28. State Bank of India joins JPMorgan's blockchain payments network

State Bank of India has tied up with JPMorgan to use the US bank's blockchain technology to speed up overseas transactions. The tie-up is expected to reduce SBI customers' transaction costs and time taken for payments. Venkat Nageswar, deputy MD - international banking group, SBI.



29. Paytm-Ola-IndusInd Bank to apply for New Umbrella Entity (NUE) to launch payments network

Ola Financial, Paytm and IndusInd Bank are planning to apply for a New Umbrella Entity (NUE) license to set up a domestic payments network similar to the National Payments Corporation of India's (NPCI) unified payments interface (UPI). The consortium will submit its proposal to the RBI

30. Finance Minister Smt. Nirmala Sitharaman inaugurated Competition Commission of India's South Regional Office in Chennai

Union Minister for Finance and Corporate Affairs Smt. Nirmala Sitharaman virtually inaugurated the CCI Regional Office (South) in Chennai in the august presence of Union Minister of State for Finance & Corporate Affairs Shri Anurag Singh Thakur. CCI:- Founded: 14 October 2003; HQ: New Delhi

Economy

1. Budget 2021-22 proposals rest on 6 pillars; fiscal deficit is set to jump to 9.5% of GDP in 2020-21 as per Revised Estimates.

6 pillars:health and well-being,physical,financial capital and infrastructure,inclusive development for aspirational India,reinvigorating human capital,innovation and R&D & minimum government and maximum governance.Deficit is higher than 3.5% projected. Personal income tax slabs remain as is.

2. Budget 2021:137% hike in health & wellness budget, new PM Atmanirbhar Swasth Bharat scheme announced

Includes a '60,030 crore outlay on drinking water and sanitation,a '2,700 crore outlay on nutrition,'35,000 crore toward vaccination etc. The new scheme meant to strengthen the health system, will be launched with an outlay of Rs 64,180 crore over six years. Outlay for health and well-being is Rs 2,23,846 crore in 2021-22

3. Budget 2021: Increase in insurance FDI limit, PSB recapitalisation, Privatisation of 2 PSBs & 1 General Insurance

Increase in FDI limit in insurance from 49% to 74% & allow foreign ownership and control with safeguards; provision of Rs 20,000 crore for PSB recapitalisation in 2021-22; bad bank-like structure through ARC and AMC to be set up To Resolve NPAs. IPO of LIC as part of Rs 1.75-lakh-crore disinvestment plan

4. Budget 2021:Voluntary Vehicle scrapping policy, Production Linked Incentive scheme, Mega Investment Textiles Parks (MITRA)

Fitness test after 20 years for personal vehicles & 15 years for commercial vehicles.Rs.1.97 lakh cr in next 5 years for PLI schemes in 13 Sectors;Rs.2,217 crore to tackle air pollution for 42 urban centres with a million-plus population. 7 Textile Parks to be established over 3 years

5. Budget 2021:National Infrastructure Pipeline(NIP)Expanded To Cover 7,400 Projects.

Measures announced include:Rs.20,000 crore to set up & capitalise a Development Financial Institution(DFI);National Asset Monetization Pipeline to be launched;Rs. 5.54 lakh crore capital expenditure in BE 2021-22 ' sharp increase of 34.5% over BE 2020-21. NIP jointly funded:central 39%, state 40% & private sector 21%.

6. Budget 2021:Power discoms get second chance, gets Rs 3.05 trillion for 5 years for a revamped reforms-based result-linked scheme.

Scheme will provide assistance to DISCOMS for Infrastructure creation. Consumers to have alternatives to choose Distribution Company for enhancing competitiveness. A comprehensive National Hydrogen Energy Mission 2021-22 to be launched to generate hydrogen. 1.41 lakh circuit km of transmission lines added in past 6 years

7. Budget 2021:Rs 1,500 Crore Scheme to boost Digital Payments; lowers loan limit for debt recovery for NBFCs.

Value of loans that can be introduced for debt recovery under SARFAESI Act lowered to Rs.20 lakh from Rs.50 lakh for NBFCs having a minimum asset size of Rs.100 crore. Government to also facilitate setting up of a world class fintech hub in GIFT city. A single Securities Markets Code to be evolved as well.

8. Budget 2021: 100 new Sainik Schools, 750 Eklavya schools will be set up, National Language Translation Mission (NLTM) introduced.

15,000 schools to be strengthened by implementing all National Education Policy components; Rs 50,000 cr allocated for the National Research Foundation for over 5 years; NLTM to make policy and government documents available in major Indian languages. Central University to come up in Leh, Ladakh.



9. Railway Budget 2021: 57% jump in allocation with Rs.1.1 lakh crore, National Rail Plan for India(2030) by Indian Railways

Of this allocation,Rs 1.07 lakh crore will be for capital expenditure;100% electrification of broad gauge routes to be completed by Dec 2023;Metro lite & metro neo to provide metro rail systems at much lesser cost in Tier 2 cities and outer areas of Tier 1 National Rail Plan is to create a 'future ready' Railway system.

10. Budget 2021: Road Min gets 'highest ever' allocation of Rs 1.18 trillion.

The allocation has gone up 2.5 times since 2014, when the new NDA government announced an outlay of Rs 33,305 crore. Tamil Nadu, Kerala, West Bengal, and Assam will get highways worth Rs 2.27 trillion. 11,000 km of NH corridors to be completed by March 2022.

11. Budget 2021:Seven major ports worth '2,000 cr. to be privatised, maiden Gas Pipeline Project in J&K

Also announced a subsidy scheme of '1,624 crore for a period of 5 years for Indian shipping companies to encourage more merchant ships with Indian flags. Capacity of recycling shipyards would be doubled from 4.5 million light displacement tonne by 2024. Pipeline, part of plan to add 100 districts to City Gas Network.

12. MCA amends definition of small companies, allows NRIs to incorporate One Person Companies(OPCs)

Paid up capital & turnover of small company shall not exceed Rs.2 cr & Rs.20 cr. Earlier it was Rs.50 lakh and Rs.2 cr.It will lighten compliance burden. Also reduced number of days a person has to stay in India to qualify as resident from 182 to 120. Allowed voluntary conversion of OPCs to private/public company.

13. Cabinet gives in-principle approval to privatise Rashtriya Ispat Nigam Ltd.

The government currently holds 100 per cent stake in the maker of crude steel. The PSU, that is a corporate entity of Visakhapatnam Steel Plant, comes under Ministry of Steel.Sale proceeds would be part of the disinvestment target for next fiscal. Govt has budgeted Rs 1.75 lakh cr from disinvestment in 2021-22.

14. State Bank of India revises FY21 GDP estimates to 7%

SBI's Economic Research Department revised FY21 GDP estimates to -7.0%. Previously it had estimated GDP at -7.4%. The report was authored by SBI's Group Chief Economic Advisor Dr Soumya Kanti Ghosh. SBI is expecting FY 22 GDP to be 11%. Chairperson of SBI: Dinesh Kumar Khara HQ: Mumbai

15. India's real GDP will grow at 10.4% in FY22: India Ratings and Research

According to India Ratings and Research India's real GDP will grow at 10.4 per cent in FY22, after a 7.8 per cent contraction in the pandemic-impacted FY21. The agency expects headline retail inflation to cool down to 4.3 per cent in FY22. India Ratings and Research (Ind-Ra) is headquartered in Mumbai.

16. Retail inflation eases to 4.06% in January; factory output grows 1% in December

Retail Inflation based on Consumer Price Index (CPI) eased to a 16-month low of 4.06% in January mainly due to a sharp decline in food prices justifying the RBI's accommodative monetary policy stance. Inflation based on CPI was at 4.59% in December. Retail Inflation: Change in the price index over a period of tim

17. GDP to grow at 13.5% in FY22; economic activity on verge of normality': Nomura

Japanese brokerage Nomura said that economic activity is on the 'verge of normality' after a pandemic. It predicted that India GDP will grow at 13.5% in FY22. It expects real GDP to contract by 6.7 per cent in FY21. RBI projected growth of 10.5% for FY22. India's real GDP to grow at 11% in 2021-22: Economic Survey.

18. India recorded \$1422 mn FDI inflow from UK in 2019-20: Grant Thornton report

According to Grant Thornton Bharat's Britain Meets the FDI inflow from the UK to India has increased from \$898 million in 2015- 16 to \$1,422 million in 2019-20. The report was



prepared in collaboration with the CII and UK's Dept of International Trade. Maharashtra was the top destination for UK Companies.





National

1. Microsoft launches its new engineering hub India Development Center(IDC) in NCR

IDC NCR is Microsoft's third Development Center in India after Bengaluru and Hyderabad. The contemporary workspace is a step towards realizing IDC's vision of being a source of innovation for the next billion users by collaborating with global teams. IDC NCR workspace architecture is inspired by the Taj Mahal

2. Vice President M Venkaiah Naidu inaugurated National Tribal Festival 'Aadi Mahotsav' at Dilli Haat, New Delhi.

The fortnight-long festival hosted by Ministry of Tribal Affairs will feature exhibition-cum-sale of tribal handicrafts, art, paintings, fabric, jewellery & much more through 200 stalls to showcase this. About 1000 tribal artisans and artists are participating. The Aadi Mahotsav is an annual event that was started in 2017.

3. Kashmir's 25-yr-old Ayesha Aziz becomes India's youngest female pilot.

In 2011,Aziz became the youngest student pilot to get a license at the age of 15 and underwent training to fly a MIG-29 jet at Russia's Sokol airbase the following year.She graduated from Bombay Flying Club & obtained license in 2017. She also underwent 2-month space training course at NASA in 2012

4. India's first geothermal power project to be established at Puga village of Ladakh

Puga village of Ladakh was identified as a hotspot of geothermal energy by scientists. In the 1st phase of the project, 1 MW power generation capacity will be generated. The Geothermal Field Development Project is planned to commission by the end of 2022. Geothermal energy - Thermal energy generated & stored in Earth.

5. India becomes fastest country to reach six million vaccinations in world

In 24 days, India became the fastest country to reach 6 mn vaccinations in the world. USA took 26 days to reach the mark while UK took 46 days to reach 6 mn vaccinations. India is the 3rd topmost country in terms of number of COVID-19 vaccine administered. COVISHIELD vaccine is manufactured by Serum Institute of India.

6. President inaugurates museum dedicated to pride of Kodagu General Thimayya in Madikeri

An ode to the pride of Kodagu, the President of India inaugurated the General Thimayya Museum in Madikeri. The museum has been built at Sunnyside, the former residence of General KS Thimayya. General KS Thimayya served as Chief of Army Staff. Kodagu is a rural district in the southwest Karnataka.

7. PM Modi inaugurates first full-fledged international cruise terminal at Cochin Port in Kerala

PM inaugurated Sagarika International Cruise Terminal marking another landmark, which has turned into a major cruise destination across the globe. He also inaugurated Cochin Shipyard's Vigyan Sagar, a campus for Marine Engineering Training Institute. Kochi is located in the Ernakulam district of Kerala.

8. Delhi-Dehradun expressway, worth '13,000 cr to be first in India to have a 12 km long elevated corridor for protecting wildlife

Transport Min Nitin Gadkari approved a new Delhi-Dehradun expressway worth '13,000 crores. It will have 10 elevated roads and it will also reduce the travel time between the cities to 3-3.15 hours. Expressway will have a minimum driving speed of 100 kmph. Budget Allocation for Highways in 2021: '1.18 lakh crore.

9. Amazon is setting up its first device manufacturing line in India

Amazon announced to develop its first manufacturing facility in India to produce Amazon Devices in Chennai. It will commence its manufacturing efforts with contract manufacturer Cloud Network Technology, a subsidiary of Foxconn located in Chennai. Amazon's Chennai unit will produce Fire TV Stick devices.



10. PM Modi to chair 6th meeting of Governing Council of NITI Aayog virtually

PM to chair 6th meeting of Governing Council of NITI Aayog. The meeting will witness entry of Ladakh for the 1st time in addition to J&K. It will also be attended by ex-officio members of Governing Council, Ministers, Vice Chairman & Members of NITI Aayog. Chairperson of NITI Aayog: The Prime Minister of India.

11. Go Electric campaign launched to ensure energy security in the country

Centre launched the Go Electric campaign to boost the adoption of electric mobility vehicles & electric cooking appliances to ensure energy security in India. It aims to reduce import dependence and is being promoted as a step towards a greener future. Fossil fuels have an import bill of '8 lakh crore.

12. 25 cities selected for Nurturing Neighbourhoods Challenge

MoHUA announced names of 25 cities selected for the Nurturing Neighbourhoods Challenge in collaboration with the Bernard van Leer Foundation under Smart Cities Mission. The cities would carry out projects for making early childhood-friendly neighbourhoods The Challenge is a 3-year initiative.

13. International Solar Alliance (ISA) to Launch World Solar Bank

The ISA has planned to launch the World Solar Bank (WSB) at the United Nations Climate Change Conference in Glasgow that is scheduled for November 2021. The World Solar Bank will support India's attempt to secure its leadership in the climate arena. The HQ of World Solar Bank is expected to be set up in India.

14. PM Modi inaugurates Dr. Syama Prasad Mookerjee Institute of Medical Sciences & Research at IIT Kharagpur

Prime Minister Narendra Modi inaugurated Dr Syama Prasad Mookerjee Institute of Medical Sciences and Research at IIT Kharagpur. The super speciality hospital was set up by the Ministry of Education. He also addressed the 66th Convocation of IIT Kharagpur. MBBS programme is expected to start from academic year '21-22.

15. Rajnath Singh inaugurates 26th edition of 'Hunar Haat'

Defence Minister Rajnath Singh inaugurated the 26th edition of 'Hunar Haat' in New Delhi. The government's craft fair Hunar Haat focuses on enabling micro-businesses involving artisans and craftsmen to sell and promote their products. Hunar Haat gives emphasis on Vocal for Local.

16. Ministry of Housing and Urban Affairs approves construction of 56,368 houses under PMAY-U

The construction of PMAY-U houses are in various stages. As of now, more than 73 Lakh houses have been grounded and nearly 43 Lakh have been completed. These houses are proposed to be constructed under various verticals of PMAY-U Mission. Pradhan Mantri Awas Yojana (Urban)-PMAY (U).




20. Indian men's skeet team wins bronze in ISSF World Cup





3. Bellatrix Aerospace is building a 'space taxi' for satellites

Bengaluru based Bellatrix Aerospace, founded in 2015, is building an Orbital Transfer Vehicle (OTV) that will work as taxi in space to ferry small satellites into multiple orbits. It could be a big development for global operators to reduce time and costs. Founders: Yashas Karanam; Rohan M Ganapathi

4. Hindustan Aeronautics Limited (HAL) to develop unmanned pseudo satellite that can fly unmanned for upto 3 months

Hindustan Aeronautics Limited is developing a futuristic high altitude pseudo satellite with a start-up company, a first of its kind in the world. The satellite will be solar energised and become a big asset flying unmanned around 70,000 ft for 2-3 months. The technology is named Combined Air Teaming System (CATS).

5. SpaceX announces its first all-civilian mission to Space

Elon Musk's SpaceX announced the launch of its first all civilian mission to space. It is planning Falcon 9's launch of Inspiration4, the world's 1st all-commercial astronaut mission to orbit. It will be launched from NASA's Kennedy Space Center in Florida Jared Isaacman, a trained pilot will be commanding the mission.

American space agency NASA successfully landed its 5th rover Perseverance on Mars in a deep crater near its equator called Jezero. The 6-wheeled vehicle will now spend at least next 2 years drilling into the local rocks, looking for evidence of past life. The rover is only the fifth ever to set its wheels down on Mars.

8. In a first, Hydrogen fuel bus service to start on Delhi-Jaipur route

In a first, India's largest energy conglomerate, National Thermal Power Corporation Limited (NTPC Ltd) is planning to start a premium hydrogen fuel bus service on Delhi to Jaipur route. 

3. India's first CNG tractor launched; Farmers' annual fuel cost can go down by Rs 1 lakh



5. Old Kanchoth festival celebrated across J&K's Chenab valley

Nag followers who believe that on this day of Gouri Tritiya, Shiva & Parvati got married and the latter insisted on a throne made of snow as her wedding gift. Snow during the festival is considered a good omen.





Union Budget 2021-22 Highlights

- FM Nirmala Sitharaman in her Union Budget 2021-22 speech in the parliament announced FDI limit in insurance to be increased to 74% from now existing 49%. Govt has allowed foreign ownership in insurance with safeguards.
- The govt will also launch a Securities Market Code which will include SEBI Act, Govt Sec act, Depositories Act. SEBI will be notified as regulator for a gold exchange. FM said that the govt is proposing to strategically divest 2 PSU banks and 1 general insurance company.
- FM Nirmala Sitharaman has also announced measures under Aatmanirbhar Package. She said the early PM garib Kalyan Yojana amounted to almost presenting 5 "mini budgets" in 2020. She proposed strengthening of 'Sankalp of Aatmanirbhar Bharat'. Focus on 6 pillars, which include Health & Well-being, Inclusive Development, Human Capital, Innovation and R&D. FM added that the govt is fully prepared to support and facilitate economic growth and they are introducing Aatmanirbhar Swastha Bharat Yojana with an outlay of Rs 64,180 crore.
- FM announced that Jal Jeevan Mission Urban will be launched with and outlay of ₹ 2.87 lakh crore over 5 years which is aimed at universal water supply in all 4,378 urban local bodies, with 2.86 crore household tap connections and liquid waste management in 500 AMRUT cities. She also announced Urban Swachh Bharat Mission 2.0 with outlay of ₹ 1,41,678 crore over 5 years from 2021 focused on complete fecal sludge management, waste water treatment, source segregation, management of waste from urban construction, bioremediation of legacy dump sites.
- Announcing major infrastructure boost, FM announced highway works in various states including 3,500 km corridor in Tamil Nadu, 1,100 km in Kerala at investment of Rs 65,000 crore, 675 km in West Bengal at a cost of Rs 95,000 crore and 1,300 km in Assam in the next 3 years. In May 2020, Govt announced the Atmanirbhar Bharat package, to sustain the recovery further we also rolled out two more Atmanirbhar packages. Total financial impact of all packages including measures taken by RBI was estimated to be about Rs 27.1 lakh crores, Sitharaman added.
- For Railways Budget, the FM announced that <u>Indian Railways</u> will have a **National Rail Plan** for upto 2030. For aviation sector, FM said that the next lot of airports will be privatized in tier 2 and 3 towns and cities. FM said that in FY22 outlay (budget estimate) for health & well-being is up 138%, and is at Rs 2,23,846 crore. Govt has also allocated Rs 35,400 crore towards COVID vaccines for FY22 and is committed to more if required. She said Modi govt is committed to achieving targets laid out under the national infrastructure pipeline. Ujjwala scheme will be expanded to over 1 crore more beneficiaries. We will add 100 more districts in the next three years to the city gas distribution network. A gas pipeline project will be taken up in Jammu and Kashmir, FM said.
