## Recruitment to the post of Assistant Manager in Grade 'A' (RDBS / Legal /Protocol & Security Service)

Applications are invited from Indian citizens for the post of **Assistant Manager** in Grade 'A' in the Rural Development Banking Service (RDBS) /Legal / Protocol & Security Service in National Bank for Agriculture and Rural Development (NABARD). Candidates can apply only **ONLINE** on NABARD website <a href="https://www.nabard.org">www.nabard.org</a> **between 08 November 2025 and 30 November 2025.** NABARD is an all India Apex Organization, wholly owned by Government of India and is an equal opportunity employer.

Before applying, candidates should read all the instructions carefully and ensure that they fulfil all the eligibility criteria for the post. NABARD would admit candidates on the basis of the information furnished in the ONLINE application along with applicable requisite fee and shall verify their eligibility at the stage of interview / joining. If, at any stage, it is found that any information furnished in the ONLINE application is false/ incorrect or if according to the Bank, the candidate does not satisfy the eligibility criteria for the post, his/ her candidature will be cancelled and he/she will not be allowed to appear for the interview / joining.

Candidates are requested to apply only <u>ONLINE</u> through Bank's website www.nabard.org. No other mode of submission of application will be accepted by NABARD.

Reservation for PWBD candidates shall be applied horizontally within the overall vacancies earmarked for various categories viz., UR, SC, ST, OBC & EWS for Grade A (RDBS) post.

- (i) The reservation will be provided for candidates belonging to SC/ST/OBC/EWS/PWBD category as per extant Government of India instructions.
- (ii) NABARD reserves the right to increase / decrease the number of vacancies in any of the disciplines or not to fill up any of the vacancies or cancel the recruitment process, as per its requirement.
- (iii) Candidates belonging to OBC category but coming in the 'Creamy Layer' are not entitled to OBC reservation. They should indicate the category as 'General' (Gen).

- (iv) Reserved category candidates desirous of applying for the posts where the vacancies are not reserved, should apply under UR category.
- (v) Out of 85 vacancies of Asst. Manager (RDBS), 07 vacancies are reserved for PWBD candidates under RPWD Act 2016 as per the details given in Table below. The overall PWBD vacancies include 02 (Category a), 02 (Category b), 02 (Category c), and 01 (Category d+e).

All 07 PWBD vacancies reserved for Asst. Manager (RDBS) are open to General & Specialised disciplines.

(vi) The candidates from PWBD category for AM(RDBS) posts will be eligible for age relaxation and exemption from payment of application fee. However, they will have to pay the intimation charges.

(vii) There is no reservation for PWBD candidates for the posts of Legal Service and Protocol & Security Service. However, PWBD candidates belonging to categories as indicated in the Table III and Table IV above and subject to their eligibility, may apply for these posts, without any concession except for age relaxation. (No age relaxation for the post of Assistant Manager (Protocol & Security Service) in Grade 'A'.

#### **Note for PWBD:**

- 1. **<u>Visually Challenged (VC)</u>**: Only those Visually Challenged persons who suffer from any one of the following conditions are eligible to apply.
  - i. Total absence of sight.
  - ii. Visual acuity not exceeding 6/60 or 20/200 (Snellen) in the better eye with correcting lenses.
  - iii. Limitation of the field of vision subtending an angle of 20 degrees or worse

Applicants having low vision as defined under the Schedule - Specified Disability of RPWD Act 2016.

PWBD candidates may belong to any category (UR/SC/ST/OBC/EWS). Reservation for PWBD is horizontal and within the overall vacancies for the post.

#### 2. (i) Guidelines for Persons with Benchmark Disabilities using a Scribe

The visually impaired candidates and candidates whose writing speed is adversely affected permanently for any reason can use their own scribe at their cost during the online examination, subject to limits as in (ii) and (iii) below. In all such cases where a scribe is used, the following rules will apply:

- i. The candidate will have to arrange his/her own scribe at his/her own cost.
- ii. The scribe arranged by the candidate should not be a candidate for the same examination. If violation of the above is detected at any stage of the process, candidature of both the candidate and the scribe will be cancelled. Candidates eligible for and who wish to use the services of a scribe in the examination should invariably carefully indicate the same in the online application form. Any subsequent request will not be entertained.
- iii. A person acting as a scribe for one candidate cannot be a scribe for another candidate.
- iv. The scribe may be from any academic stream. However, for posts in disciplines other than "General", the scribe should be from an academic stream different from that prescribed for the post.
- v. Both the candidate as well as scribe will have to give a suitable undertaking confirming that the scribe fulfils all the stipulated eligibility criteria for a scribe mentioned above. Further in case it later transpires that he/she did not fulfil any laid down eligibility criteria or suppressed material facts the candidature of the applicant will stand cancelled, irrespective of the result of the online examination and interview / final result.
- vi. Those candidates who use a scribe shall be eligible for compensatory time of twenty minutes for every hour of the examination or as otherwise advised.
- vii. Only candidates registered for compensatory time will be allowed such concessions since compensatory time given to candidates shall be system based, it shall not be possible for the test conducting agency to allow such time if he / she is not registered for the same. Candidates not registered for compensatory time shall not be allowed such concessions.
- viii. The candidate should opt for using scribe/ compensatory time only if they are eligible for availing these services/concessions as per the rules and guidelines of Government of India under RPWD Act, 2016 in this regard.
- ix. The scribe will be allowed to be used as per the guidelines issued vide Office Memorandum F.No.16-110/2003-DDIII dated February 26, 2013 of Government of India, Ministry of Social Justice and Empowerment, Department of Disability Affairs, New Delhi.
- x. During the exam, at any stage, if it is found that scribe is independently answering the questions, the exam session will be terminated and candidate's candidature will be cancelled. The candidature of such candidates using the services of a scribe will also be cancelled if it is reported after the examination by the test administrator personnel that the scribe independently answered the questions.

In addition to instructions applicable to PWBD candidates (who have disability of 40% or more), following rule will apply for persons with specified disabilities covered under the

definition of Section 2(s) of the RPWD Act, 2016 but not covered under the definition of Section 2(r) of the said Act, i.e. persons having less than 40% disability and having difficulty in writing.

- The facility of scribe and/or compensatory time shall be granted solely to those having difficulty in writing subject to production of a certificate to the effect that person concerned has limitation to write and that scribe is essential to write examination on his/her behalf from the competent medical authority of a Government healthcare institution as per proforma at <a href="Appendix-III">Appendix-III</a>.
- The qualification of a scribe should be one step below the qualification of the candidate taking examination. The person opting for own scribe should submit details of the own scribe as per proforma at <a href="Appendix-IV">Appendix-IV</a>.

#### (ii) Guidelines for Candidates with Locomotor Disability and Cerebral Palsy

A compensatory time of twenty minutes per hour or otherwise advised shall be permitted for the candidates with locomotor disability and cerebral palsy where dominant (writing) extremity is affected to the extent of slowing the performance of function (minimum of 40% impairment).

### (iii) Guidelines for Visually Impaired Candidates

Visually Impaired candidates (who suffer from not less than 40% of disability) may opt to view the contents of the test in magnified font and all such candidates will be eligible for compensatory time of twenty minutes for every hour of examination.

**Note**: Only those persons with benchmark disabilities would be eligible for reservation. "Benchmark disability" means a person with not less than 40% of a specified disability where specified disability has not been defined in measurable terms and includes the persons with certifying authority. A person who wants to avail benefit of reservation will have to submit a disability certificate issued by a Competent Authority as per Government of India guidelines (<u>Appendix I</u> / <u>Appendix II</u>). Such certificate will be subject to verification/ re-verification as may be decided by the competent authority.

Candidates seeking reservation/relaxation benefits available for PWBD must ensure that they are entitled to such reservation/relaxation as per eligibility prescribed. They should also be in possession of the PWBD certificate, in the prescribed format (Appendix I / Appendix II) in support of their claim as stipulated for such benefits. These certificates should be dated on or before the closing date of application for the post.

The guidelines for PWBD/EXS/EWS applicants are subject to change in terms of GoI guidelines/ clarifications, if any, from time to time.

#### II. Reservation for Economically Weaker Section (EWS)

Persons who are not covered under the scheme of reservations for SCs, STs and OBCs and whose family has gross annual income below Rs.8.00 lakh (Rupees eight lakh) and fulfilling Government of India criteria for EWSs, are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources, i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.

Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:

- i. 5 acres of agricultural land and above;
- ii. Residential flat of 1000 sq. ft. and above
- iii. Residential plot of 100 sq. yards and above in notified municipalities;
- iv. Residential plot of 200 sq. yards and above in areas other than the notified municipalities

The guidelines for PWBD/EXS/EWS applicants are subject to change in terms of GoI guidelines/ clarifications, if any, from time to time.

#### III. ELIGIBILITY CRITERIA: Educational Qualification (as on 01.11.2025)

- a) A candidate can apply for Assistant Manager (RDBS/Legal/Protocol & Security) from among the options given in **Table-I** (only one option). It is clarified that candidate applying for Asst. Manager (RDBS) General cannot apply for another discipline and vice versa. Similarly, candidates applying for Asst. Manager (Legal) or Asst. Manager (Protocol & Security) cannot apply for Asst. Manager (RDBS) and vice versa.
- b) The candidate can apply only for ONE Post/Discipline of his / her choice. In case of multiple applications across or within disciplines for Grade A (RDBS), only the last application submitted will be considered valid and fee against all other applications will be forfeited.
- c) PWBD candidates applying against Unreserved (UR) posts will not be eligible for relaxation in percentage in Educational Qualification. They may, however, be eligible for relaxation in Age and Fee.

## No age relaxation for the post of Assistant Manager (Protocol & Security Service) in Grade 'A'.

- d) The candidate must possess the required educational qualification as on 01.11.2025. The result of final term / semester/ year examination of the required educational qualification must have been declared on or before 01.11.2025. In other words, candidates whose final year/semester results have been declared after 01.11.2025 are not eligible to apply.
- e) In case the certificate of degree/diploma does not specify the field of specialization, the candidate will have to produce a certificate from the concerned university/college specifically mentioning the specialization.

Bachelor's Degree in a particular discipline means that the candidate must have studied that discipline as main subject in respective degree course and it must be mentioned in the Degree Certificate issued by the University/Institute.

#### 1. Academic Qualifications:

## (A) Assistant Manager in Grade 'A' (RURAL DEVELOPMENT BANKING SERVICE) (RDBS)

#### (i) General

Bachelor's Degree in any subject from any recognized University/Institution with a minimum of 60% marks (SC/ST/PWBD applicants - 55%) in aggregate **OR** Post Graduate degree, MBA/PGDM with a minimum of 55% marks (SC/ST/PWBD applicants - 50%) in aggregate OR CA/ CS/CMA/ ICWA OR Ph.D from Institutions recognized by GOI/UGC .

#### (ii) Chartered Accountant

Bachelor's degree in any discipline from any recognized University/Institution with Membership of Institute of Chartered Accountants of India (ICAI). The Membership of ICAI must have been obtained on or before 01-11-2025.

#### (iii) Company Secretary

Bachelor's degree in any discipline from any recognized University/Institution with Associate/Fellow membership of Institute of Company Secretaries of India (ICSI). The Membership of ICSI must have been obtained on or before 01-11-2025.

#### (iv) Finance:

BBA (Finance / Banking) / BMS (Finance / Banking) from any recognized University / Institution with 60% marks (SC/ST/PWBD applicants - 55%) in aggregate

### <u>OR</u>

Two years full time P.G. Diploma in Management (Finance) / Full time MBA (Finance) /MMS (Finance) degree with 55% marks (SC/ST/PWBD applicants - 50%) in aggregate from Institutions / Universities recognized by GoI /UGC with Bachelor's Degree in any discipline. Candidates will be required to submit a certificate from Institution/University regarding specialization in finance.

#### OR

Bachelor of Financial and Investment Analysis with 60% marks (SC/ST/PWBD applicants - 55%)

#### <u>OR</u>

Bachelor's degree in any discipline from any recognized University/Institution with Membership of Institute of Chartered Accountants of India (ICAI). The Membership of ICAI must have been obtained on or before 01-11-2025.

#### OR

Bachelor's degree in any discipline from any recognized University/Institution with Membership of Institute of Cost and Management Accountants of India (ACMA/FCMA/ICWA). The Membership of ICMAI must have been obtained on or before 01-11-2025.

#### **OR**

Bachelor's Degree in any discipline from any recognized University/Institution with Chartered Financial Analyst certification from (CFA Institute-USA) or Financial Risk Manager (FRM) certification from Global Association of Risk Professionals (GARP).

#### (v) Computer/Information Technology:

Four years Bachelor's Engineering/Technology Degree in Computer Science/Computer Engineering/ Computer Applications/ Information Technology / Electronics / Electronics & Telecommunications/ Electronics & Communication/ Data Science / Artificial Intelligence and Machine Learning from any recognized University/Institution with 60% marks (SC/ST/PWBD applicants 55%) in aggregate

**OR** Post Graduate degree in Computer Science/ Computer Engineering / Computer Applications/Information Technology / Electronics/ Electronics & Telecommunications/ Electronics & Communication/ Data Science / Artificial Intelligence and Machine Learning with 55% marks (SC/ST/PWBD applicants 50%) in aggregate from any recognized University/Institution

**OR** Graduate with 60% marks (SC/ST/PWBD applicants 55%) in aggregate from any recognized University/Institution **AND** having passed Department of Electronics and Accreditation of Computer Courses (DOEACC) 'B' Level.

#### (vi) Agriculture Engineering:

Bachelor's Degree in Agriculture Engineering from any recognized University with a minimum of 60% marks (PWBD applicants - 55%) in aggregate **OR** Post Graduate degree in Agriculture Engineering with a minimum of 55% marks (PWBD applicants - 50%) in aggregate from any recognized University/Institution.

#### (vii) Plantation & Horticulture

Bachelor's Degree in Horticulture from any recognized University with a minimum of 60% marks (PWBD applicants - 55%) in aggregate <u>OR</u> Post Graduate degree in Horticulture with a minimum of 55% marks (PWBD applicants - 50%) in aggregate from any recognized University/Institution.

#### (viii) <u>Fisheries</u>

Bachelor's Degree in Fisheries Science from a recognized University/Institution with 60% marks (ST/PWBD applicants 55%) in aggregate OR Post graduate degree in Fisheries Science with 55% marks (ST/PWBD applicants 50%) in aggregate from any recognized University/Institution.

#### (ix) Food Processing:

Bachelor's Degree in Food Processing /Food Technology /Dairy Technology from a recognized University/Institution with 60% marks (SC/PWBD applicants - 55%) in aggregate **OR** Post graduate degree in Food Processing /Food Technology /Dairy Technology with 55% marks (SC/PWBD applicants - 50%) in aggregate from any recognized University/Institution.

#### (x) Land Development & Soil Science

Bachelor's Degree in Soil Science/Agriculture/Environmental Science from any recognized University/Institution with 60% marks (PWBD applicants - 55%) in aggregate **OR** Post graduate degree in Soil Science/Agriculture/Environmental Science with 55% marks (PWBD applicants - 50%) in aggregate from a recognized University/Institution.

#### (xi) Civil Engineering

Bachelor's Degree in Civil Engineering/Structural Engineering from any recognized University/Institution with 60% marks (SC/ST/PWBD applicants - 55%) in aggregate **OR** Post Graduate Degree in Civil Engineering/Structural Engineering with a minimum of 55% marks (SC/ST/PWBD applicants - 50%) in aggregate from any recognized University/Institution.

### (xii) Electrical Engineering

Bachelor's Degree in Electrical Engineering/Electrical & Electronics Engineering/Power Systems from any recognized University/Institution with 60% marks (PWBD applicants - 55%) in aggregate <u>OR</u> Post Graduate Degree in Electrical Engineering/Electrical & Electronics Engineering/Power Systems with 55% marks (PWBD applicants - 50%) in aggregate from any recognized University/Institution.

#### (xiii) Media Specialist

Post graduate degree in Mass Media/Mass Communication/Communication/ Journalism from a recognized University/Institution with 55% marks (PWBD applicants - 50%) in aggregate from any recognized University/Institution.

#### (xiv) Economics

Post Graduate degree in Applied Economics with a minimum of 55% marks (SC/PWD applicants-50%) in aggregate from any recognized University/Institution.

Candidates with Economics as one of the main subjects at all years/semesters of the course, will only be eligible.

#### (B) <u>Assistant Manager in Grade 'A' (LEGAL SERVICE)</u>

Bachelor's Degree in Law recognized by UGC and Bar council of India for the purpose of enrolment as an Advocate with a minimum of 60% marks in the aggregate of all semesters/years OR LLM Degree with a minimum of 55% in the aggregate of all semesters/years.

Note: In case of practicing advocates (i) copy of Bar Council Registration Certificate and (ii) A Certificate from Bar Association of which the candidate is a member or a certificate issued by the Presiding Officer of a court before which the candidate has practiced for the required period should be produced at the time of interview.

<u>NOTE</u>: All educational qualifications should have been obtained from Universities / Institutions incorporated by an Act of Central or State Legislature in India or other educational institutions established by an Act of Parliament or declared to be deemed as a University under Section -3 of UGC Act 1956.

i. Some Universities/Institutes do not award Class or percentage of marks and allot Aggregate Grade Points (e.g. CGPA/OGPA/CPI, etc.). In case University/Institute defines criteria for conversion of Aggregate Grade Point into Class and/or percentage of marks, the same will be accepted. However, where the University/Institute does not define criteria for conversion of Aggregate Grade Point into Class and/or percentage of marks, the undefined parameter(s) would be worked out as under:

Aggregate Grade Point or percentage of marks where awarded would mean aggregate over the entire duration of the course.

- ii. Where the Aggregate Grade Point (CGPA/OGPA/CPI, etc.) is awarded out of a number other than 10, it will be normalized out of 10 and computed as per item (i) above.
- iii. Calculation of percentage: The percentage marks shall be arrived at by dividing the total marks obtained by the candidate in all the subjects in all the semester(s)/year(s) by aggregating maximum marks in all the subjects irrespective of honors / optional / additional optional subject, if any. This will be applicable for those Universities also where Class/Grade is decided on the basis of Honor's marks only. #### C. Process for Arriving at Scores

The Scores of Online Examination are obtained by adopting the following procedure:

- (i) Number of questions answered correctly by a candidate in each objective test is considered for arriving at the Corrected Score after applying penalty for wrong answers.
- (ii) The Corrected Scores so obtained by a candidate are made equivalent to take care of the minor difference in difficulty level, if any, in each of the objective tests held in different sessions to arrive at the Equated Scores\*
- \* Scores obtained by candidates on any test are equated to the base form by considering the distribution of scores of all the forms.
- (iii) Testwise scores and scores on total is reported with decimal point upto two digits.

The calling Ratio to qualify for the main examination and interview would be a maximum of 1:25 and 1:3, respectively. The ratio may be suitably reduced at the discretion of the bank. Candidates who qualify and rank sufficiently high as decided by NABARD, shall be called for appearing at the Main Examination and Interview. There will be penalty for wrong answers marked by the candidate. **C.** The Interview may be held at a few of the above Centres which will be communicated in the interview call letter.

**Note:** Candidates can select only one centre for Phase-I and one centre for Phase-II/Phase III separately and must indicate the choice of centres in the online application.   - Size of file should be between 10KB 20KB for signature and 20KB 50KB for left thumb impression.
  - o Ensure that the size of the scanned image is not more than 20KB
- The applicant has to put his left thumb impression on a white paper with black or blue ink.
  - o <u>File type:</u> jpg / jpeg
  - Dimensions: 240 x 240 pixels in 200 DPI (Preferred for required quality) i.e 3 cm \* 3 cm (Width \* Height)
  - <u>File Size:</u> 20 KB 50 KB
- The applicant has to write the declaration in English clearly on a white paper with black ink.
  - o <u>File type</u>: jpg / jpeg
  - O Dimensions: 800 x 400 pixels in 200 DPI (Preferred for required quality) i.e 10 cm \* 5 cm (Width \* Height)
  - File Size: 50 KB 100 KB
- The signature, left thumb impression and the hand written declaration should be of the applicant and not by any other person.
- If the Applicant's signature on the attendance sheet or Call letter, signed at the time of the examination, does not match the signature uploaded, the applicant will be disqualified.
- Signature / Hand written declaration in CAPITAL LETTERS shall NOT be accepted.

#### Scanning the Photograph Image and Signature:

- Set the scanner resolution to a minimum of 200 dpi (dots per inch).

Candidates are advised in their own interest that they should not furnish any particulars that are false, tampered with or fabricated and should not suppress any material information while submitting online application. At the time of examination, interview or in a subsequent selection procedure, if a candidate is (or has been ) found guilty of –

- (i) using unfair means or
- (ii) impersonating or procuring impersonation by any person or
- (iii) misbehaving in the examination/ interview hall or disclosing, publishing, reproducing, transmitting, storing or facilitating transmission and storage of contents of the test(s) or any information therein in whole or part thereof in any form or by any means, verbal or written, electronically or mechanically for any purpose or
- (iv) resorting to any irregular or improper means in connection with his/ her candidature or
- (v) obtaining support for his/her candidature by unfair means, or
- (vi) carrying mobile phones or similar electronic devices of communication in the examination/ interview hall, such a candidate may, in addition to rendering himself/ herself liable to criminal prosecution, be liable:
  - a. to be **disqualified from** the examination for which he/ she is a candidate
  - b. to be **debarred** either permanently or for a specified period from any examination conducted by bank
  - c. for **termination** of service, if he/ she has already joined the Bank.

#### XIV. GENERAL INSTRUCTIONS

#### 1. DOWNLOAD OF CALL LETTER

Candidates will have to visit NABARD's website for downloading call letters for online test (Phase I, II and III). Intimation for downloading call letter will also be sent through email/SMS. Once the candidate clicks the relevant link, he/she can access the window for call letter download. The candidate is required to use (i) Registration Number/Roll Number, (ii) Password/Date of Birth for downloading the call letter. Candidate needs to affix recent recognizable photograph on the call letter preferably the same as provided during registration and appear at the examination centre with (i) Call Letter (ii) Photo Identity Proof as stipulated in clause (iii) below and also specified in the call letter and photocopy of the same Photo Identity Proof as brought in original.

#### 2. CANDIDATES REPORTING TIME

CANDIDATES REPORTING LATE i.e. after the reporting time specified on the call letter for Examination will not be permitted to take the examination. The reporting time mentioned on the call letter is prior to the Start time of the test. Though the duration of the examination is three hours, candidates may be required to be at the venue for about 4 hours including the time required for completion of various formalities such as verification and collection of various requisite documents, logging in, giving of instructions.

#### 3. **IDENTITY VERIFICATION**

In the examination hall for each shift as well as at the time of interview, the call letter along with original and a photocopy of the candidate's currently valid photo identity (bearing exactly the same name as it appears on the call letter) such as PAN Card/ Passport/ Permanent Driving Licence/ Voter's Card/ Bank Passbook with photograph/ Photo identity proof issued by a Gazzetted Officer on official letterhead along with photograph / Photo identity proof issued by a People's Representative on official letterhead along with photograph / valid recent Identity Card issued by a recognized College/ University/ Aadhar card/ E-Aadhar Card with a photograph/ Employee ID/ Bar Council Identity Card with photograph should be submitted to the invigilator for verification. The candidate's identity will be verified with respect to his/her details on the call letter, in the Attendance List and requisite documents submitted. If identity of the candidate is in doubt the candidate may not be allowed to appear for the Examination.

#### Ration Card and Learner's Driving License are not valid id proof.

- Note: (i) In order to facilitate verification of identity at various stages of the recruitment process, candidates are advised to possess/acquire valid document Identity Documents for the recruitment process. Accordingly, the candidates may be asked to enter the details of the identity proof/s if required in the application form.
- (ii) On the day of examination, candidates will be required to report at the Exam centre well in advance of the reporting time indicated on the Call letter to complete activities such as AADHAR linked Biometric Authentication of the candidate, capture of biometric and photo, collection of documents, announcement of instructions and logging in etc. **The candidates are required to carry Aadhar Card to facilitate biometric Authentication.**
- (iii) Candidates have to produce in original the photo identity proof and submit photocopy of the photo identity proof along with Examination call letter as well as the Interview Call Letter while attending the examination/ interview respectively, without which they will not be allowed to take up the examination/ interview. Candidates must note that the name as appearing on the call letter (provided during the process of registration) should exactly match the name as appearing on the photo identity proof. Female candidates who have changed first/last/middle name post marriage must take special note of this. If there is any mismatch between the name indicated in the Call Letter and Photo Identity Proof the candidate will not be allowed to appear for the examination. In case of candidates who have changed their name, will be allowed only if they produce original Gazette notification / their original marriage certificate / affidavit in original.
- 4. Admission to the online examination (Phase I, II & III) will be purely provisional without verification of age/qualification/category (SC/ST/OBC/PWBD/EWS/EXS) etc., of the applicants with reference to documents. Each applicant should, therefore, ensure that he/she fulfils the eligibility criteria and that the particulars furnished in applications are complete/correct in all respects. In case it is detected at any stage an applicant does not fulfil the eligibility criteria and/or he/she furnished incorrect information or suppressed any material information, his/her candidature will be cancelled and, if already appointed, his/her services may be summarily terminated without giving any notice.
- 5. Applicants already in service of Govt. / Quasi-Govt. Organisations and Public Sector Banks/ Undertakings will have to produce a "No Objection Certificate" from their employer,

at the time of Interview. Before appointment in the Bank, a proper discharge certificate from the employer will have to be produced by the applicant.

- 6. No applicant is permitted to use or have possession of Calculators, Mobile Phones, Blue tooth devices or any other instrument/ device /gadget in the Examination Hall.
- 7. The applicants will have to reach the exam venue and appear for the online examination (Phase I, II and III), at their own cost.
- 8. Only one online application for any one post/ discipline should be submitted by the candidate. In case of more than one application for the same post only the last valid (completed) application will be retained and the application fee / intimation charges paid for the other registrations will stand forfeited.
- 9. Any legal proceedings in respect of any matter of claim or dispute arising out of this advertisement and/ or an application in response thereto can be instituted only in Mumbai and courts/ tribunals/ forums at Mumbai only shall have sole & exclusive jurisdiction to try any clause/ dispute.
- 10. The possibility for occurrence of some problems in the administration of the examinations cannot be ruled out completely, which may impact test delivery and/or result from being generated. In that event, every effort will be made to rectify such problem, which may include movement of candidates, delay in test. Conduct of a re-exam is at the absolute discretion of NABARD/test conducting body. Candidates will not have any claim for a retest. Candidates not willing to move or not willing to participate in the delayed process of test delivery shall be summarily rejected from the process.
- 11. The **Competent Authority** for the issue of certificates to SC/ST/OBC/PWBD/EWSs are as under:

### (a) For SC/ST/OBC:

District Magistrates/ Additional District Magistrates/ Collector/ Deputy Commissioner/ Additional Deputy Commissioner/ Deputy Collector/ First Class Stipendiary Magistrate/ City Magistrate/ Sub Divisional Magistrate (not below the rank of First Class Stipendiary Magistrate)/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner. Chief Presidency Magistrate/ Addl. Chief Presidency Magistrate/ Presidency Magistrate. Revenue Officer not below the rank of Tehsildar. Sub Divisional Officer of the area where the applicant and/ or his/ her family normally resides or as stipulated by the Govt. of India.

The SC/ST/OBC candidates from Maharashtra are also required to submit validity certificate issued by the Scrutiny Committee.

Note: For OBC applicants, only the castes/ sub-castes figuring in the Central List will be considered. Accordingly, OBC Caste/Sub-caste figuring in the concerned State list but not in Central List (Govt. of India) will not be considered under OBC category.

(b) For PWBD: Medical Board at the District level.

Only persons with permanent disability certificate are entitled for PWBD reservation.

#### (c) For OBCs:

OBC Certificate shall be in the format as prescribed by GOI and issued by the competent authority.

## The Caste Certificate for OBC candidates should be valid for the financial year 2025-2026, issued on or after 01-04-2025.

Applicants belonging to OBC category but coming in the 'CREAMY LAYER', are not entitled to OBC reservation and age relaxation. Such candidates should indicate their category as 'UR' or 'UR (OC)' or 'UR (VC)' or 'UR(HI) (as applicable).

Attested copy/copies of relevant SC / ST / OBC / PWBD / EWS certificates should be submitted in the prescribed format at the time of Interview.

#### (d) For EWSs:

- (i) District Magistrate/ Additional District Magistrate/ Collector/ Deputy Commissioner/ Additional Deputy Commissioner/ 1st Class Stipendary Magistrate/ Sub Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner
- (ii) Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/ Presidency Magistrate
- (iii) Revenue Officer not below the rank of Tehsildar and
- (iv) Sub Divisional Officer or the area where the candidate and/or his family normally resides.

## The EWS certificate should be valid for the financial year 2025-2026, issued on or after 01-04-2025.

- 12. Only those applicants who are willing to serve anywhere in India, including rural areas, need apply.
- 13. The applicants must ensure that they fulfil all the eligibility criteria and that the particulars furnished by them in the application are correct in all respects.
- 14. Eligible outstation candidates attending the interview shall be reimbursed to and fro second-class AC rail ticket (Mail/Express only) or bus fare through shortest route or actual expenses incurred (whichever is lower) on production of evidence of travel. Request for local conveyance will not be entertained. A candidate, if found ineligible for appearing in interview will not be reimbursed any travel fare.
- 15. At the time of interview, candidate shall provide details regarding criminal case(s), vigilance cases(s) pending against him/her, if any. If required, the Bank will also conduct independent verification, inter alia, including verification of police records etc. The Bank reserves the right to deny the selection/appointment depending upon such disclosures and/or independent verification.
- 16. Mere admission to the Phase I/ II/III online examinations for an applicant does not imply that the bank has been satisfied beyond doubt about the applicant's eligibility. In case it is detected at any stage that an applicant does not fulfil any of the eligibility criteria, and/ or that he/ she has furnished any incorrect information or has suppressed any material fact(s), his/her candidature will stand cancelled. If any of these shortcoming(s) is/are detected even after appointment, his/her services will be summarily terminated.
- 17. Appointment of selected applicants is subject to his/ her being declared medically fit by Medical Officer(s) appointed/ approved by the Bank.
- 18. Decision of the Bank in all matters relating to recruitment will be final and binding on the applicants and no correspondence or personal enquiries will be entertained in this regard by NABARD.

- 19. No applicant will be appointed in the Bank's service, who, (a) after such enquiry, as may be considered necessary, is not found suitable for the Bank's service and (b) after such medical examination, as the Bank may prescribe, is not found to be in good mental or physical health and free from any mental and/or physical defect likely to interfere with efficient discharge of duties.
- 20. In case any dispute arises on account of interpretation in versions other than English, the English version will prevail.
- 21. The applicants will appear for the Phase I, II and III Online Examination at the allotted centres at their expenses and risks and the Bank will not be responsible for any injury/ loss, etc. of any nature to him/ her.

## 22. PRINT OUT OF THE COMPLETED ONLINE APPLICATION SHOULD NOT BE SENT.

23. Instances for providing incorrect information and / or process violation by a candidate detected at any stage of the selection process will lead to disqualification of the candidates from the selection process and he / she will not be allowed to appear in any NABARD recruitment process in the future. If such instances go undetected during the current selection process but are detected subsequently, such disqualification will takes place with retrospective effect.

#### 24. CANVASSING IN ANY FORM WILL BE A DISQUALIFICATION

25. The Bank does not furnish the mark sheet of the selection process to candidates. The marks obtained in Phase I (online examination), Phase II examination and interview will be made available on the Bank's website in an interactive mode after recruitment process is over.

#### 26. **BIOMETRIC DATA – CAPTURING AND VERIFICATION**

It has been decided to capture the biometric data (thumb impression) and the photograph of the candidates from the Main Examination onwards. The biometric data and photograph will be verified subsequently. Decision of the Biometric data verification authority with regard to its status (matched or mismatched) shall be final and binding upon the candidates.

For Biometric process, candidates are requested to take care of the following points in order to ensure a smooth process:

- If fingers are coated (stamped ink/mehndi/coloured, etc.), ensure to thoroughly wash them so that coating is completely removed before the exam.
- If fingers are dirty or dusty, ensure to wash them and dry them before the fingerprint (biometric) is captured.
- Ensure fingers of both hands are dry. If fingers are moist, wipe each finger to dry them.
- If the primary finger (thumb) to be captured is injured/damaged, immediately notify the concerned authority in the test centre. In such cases impression of other fingers, toes etc., may be captured.
- 27. Any notice/communication meant for the candidates displayed on the Bank's website or sent by Registered/Speed Posts or conveyed to the email id mentioned in the application at the time of registration with the Bank, shall be deemed to be sufficient service of communication upon the candidate, for all purposes.
