### **Banking & Finance**

### 1. UPI transactions surpass 2-billion mark in October on festive boost

National Payments Corporation of India data shows that Unified Payments Interface registered 2.07 bn transactions, almost 82% higher than 1.14 bn transactions reported in October month last year. Transactions amounted to ₹3.86 tn in first 15 days of Oct. UPI was introduced by NPCI, a subsidiary of RBI, in **2016.** 

### 2. Reserve Bank to evaluate impact of 'RBI Kehta Hai' awareness campaign

RBI to evaluate the impact of multi-media public awareness campaign RBI Kehta Hai, which was launched in 14 languages to educate the public about safe banking and financial practices. It was the first even 360-degree campaign initiated by the central bank. RBI invited Expression of Interest from eligible companies.

#### 3. ICICI Bank launches 'Mine' for millennials

Inspired by Millennial Network ICICI Bank Mine was launched. It is an instant savings account, driven iMobile application & offers investment guidance to suit the demand of millennials. It is India's 1st full comprehensive banking programme for millennials 1st experiential branch for millennials is opened in Bengaluru.

# 4. Bank of Baroda takes a step for emotional well-being – starts employee assistance program

India's premier public sector bank, Bank of Baroda takes a pioneering step for emotional well-being – starts employee assistance program. It is a free and anonymous psychological counselling for 8,000 odd employees launched on a pilot basis. It is being carried out in association with EAP India.

### 5. RBI announces co-lending scheme for banks, NBFCs

To improve the credit flow to the underserved sections, RBI issued guidelines under the co-origination model so that non-banking finance companies (NBFCs) and banks can jointly lend. It is a joint lending process in which risks & rewards are shared. NBFCs to retain at least 20% share of individual loans on books.

### 6. SBI partners with Paytm to launch contactless credit card

State Bank of India partnered with payments platform Paytm to launch 2 models of credit cards – Paytm SBI Card& Paytm SBI Card Select. Available on VISA platform, the cards offer smart app features & also provides superior rewards & benefits for its users. Paytm CEO: **Vijay Sekhar Sharma**. SBI Chairman: Dinesh Kumar Khara

# 7. AU Small Finance Bank enters into agreement with CARE Health Insurance Company as Corporate Agent

After issuing certificate of registration CA0515 under Registration of Corporate Agents -Regulations by IRDAI AU Small Finance Bank entered into agreement with Care Health Insurance Co Ltd (formerly called Religare Insurance) for health insurance products. AU Bank HQ: Jaipur. MD & CEO: Sanjay Agarwal.

### 8. Govt provides Rs 670-crore support to RRBs to meet regulatory capital

Union government provided Rs 670 crore to RRBs considering their importance in agriculture finance. As per the current scheme, capital support is provided to these banks by Centre, concerned state governments & sponsor banks in the ratio of 50:15:35, resp. RRBs group reported net loss of Rs 2,206 crore this FY.

# 9. IFFCO Bazar Partners With SBI YONO Krishi App To Boost Accessibility Of Quality Agri-Products

IFFCO Bazar e-commerce wing of IFFCO announced its integration with SBI YONO Krishi, a dedicated portal catering to farmer's needs. It offers a wide variety of



products speciality fertilisers, organic agri-inputs, seeds, agrochemicals, agri-machinery etc., IFFCO MD: US Awasthi. YONO – You Only Need One.

### 10. SEBI enhances foreign investment cap of MFs from \$ 300 mn to \$ 600 mn

After a surge in interest in overseas investments by Indian investors, the SEBI enhanced the foreign investment limit for mutual funds to \$600 million from \$300 million with immediate effect, while capping the overall industry limit at \$7 billion. SEBI chairperson – Ajay Tyagi.

### 11. Axis Bank to acquire shares in CSC e-Governance for Rs 36 crore

Axis Bank has acquired over 57,700 shares in CSC e-Governance Services India Ltd for Rs 36.38 crore. CSC e-Governance Services India Ltd is a special purpose vehicle set up by the MeitY to oversee the implementation of the common services centre scheme. Axis Bank CEO: Amitabh Chaudhary HQ: Mumbai

## 12. Market Regulator SEBI Introduces Flexi-Cap Category For Mutual Fund Investors

To provide flexibility to mutual funds, Flexi-Cap fund was introduced. The fund will have to invest minimum 65% of total assets in equity & equity-related instruments but there will be no restriction in allocating funds across large, mid & small-cap stocks It is based on recommendations of Mutual Fund Advisory Committee.

### 13. NSE to launch first agricultural commodity futures contract in December

NSE to launch its 1st agricultural commodity futures contract for crude degummed soybean oil on December 1. Contract will facilitate the soybean oils processing & allied industries in India & overseas. It is monthly expiry cash-settled futures contract. MD & CEO of NSE: Vikram Limaye.

## 14. Karnataka Bank launches contactless RuPay National Common Mobility Card

Mangalore based Karnataka Bank launched a new RuPay debit card- National Common Mobility Debit Card. It is the bank's 1st ever contactless debit card. Equipped as an international Contact-less, it is a debit cum prepaid and inter-operable transport card. MD &CEO Mahabaleshwara Rao Tagline: Your Family Bank Across Indi

### 15. IFSCA approves draft Banking regulations for banking operations at IFSCs

International Financial Services Centres Authority regulator of IFSC including Gift City approved draft Banking regulations that will be applicable in international financial services centres. It paves way for rules for various aspects of banking operations GIFT CITY – **Gujarat International Finance Tec-City.** 

# 16. SEBI forms expert group under Sandip Bhagat to review norms related to share-based staff benefit, issue of sweat equity

Market regulator SEBI formed a seven-member expert group chaired by Sandip Bhagat Partner at S&R Associates to revisit the framework of share-based employee benefit and that of sweat equity regulations vis-a-vis the Companies Act and suggest policy changes Sweat equity shares reward employees for their contribution.

#### 17. HDFC Bank launches SmartHub Merchant Solutions 3.0 for SMEs

HDFC Bank announced the launch of SmartHub Merchant 3.0. It will allow merchants and self-employed professionals to instantly open a current account and start accepting payments in-store, online, and on-the-go. The interface is available in nine languages. HDFC Bank CEO: Sashidhar Jagdishan.



### 18. SBM Bank India set to launch a neo banking platform

SBM Bank India is focussing on technology to reach out to customers and is set to launch a neo banking platform. SBM Bank India was 1st foreign bank in India to obtain a banking licence from RBI to operate as a wholly-owned subsidiary in 2019. SBM Bank is a wholly-owned subsidiary of State Bank of Mauritius

# 19. RBI imposes Rs 1 crore penalty on Punjab National Bank for contravention of the Payment and Settlement Systems Act, 2007

RBI has imposed ₹1crore penalty for contravention of nature referred in Section 26(6) of Payment and Settlement Systems Act. RBI observed that PNB was operating a bilateral ATM sharing arrangement with Druk PNB Bank, Bhutan, without prior approval from RBI Payment & Settlement Systems Act commenced on 12th August 2008

### 20. HDFC Bank, IndusInd in 'red flag' list on nearing foreign investment cap

HDFC Bank & IndusInd Bank have been put in 'red flag' list, a system used for monitoring foreign portfolio investor (FPI) limits. A listed company enters the list when the available legroom for overseas investment is less than 3% of the permissible limit. FPIs can invest up to 74% in both HDFC Bank and IndusInd Bank.

### 21. Equitas Small Finance Bank launches "EVA" savings account for women

Equitas has launched 'Eva', unique savings account for women, offering 7% interest. Eva is available for all women - salaried/homemakers/businesswomen/senior citizens/transwomen as well as non-resident women. It also offers free health checkups. Equitas Small Finance Bank Founded: 2007.

# 22. HDFC Bank launches "Mooh Band Rakho" campaign to create awareness on cyber frauds

HDFC Bank has launched Mooh Band Rakho campaign to increase awareness on cyber frauds & preventing them. Bank will conduct 1,000 workshops in next 4 months. Bank supports International Fraud Awareness Week 2020, global movement to minimise impact of fraud. International Fraud Awareness Week 2020: November 15 to 21.

## 23. RBI published first-ever 'nowcast' - an estimate based on high-frequency data

According to the Reserve Bank's first-ever 'nowcast', India's GDP contracted 8.6% in the quarter ended September and has entered a technical recession. Nowcasting is the prediction of the existing or the very near future of the state of the economy. Nowcasting is based on 27 indicators such as automobile sales.

# 24. Natural Support Consultancy Services & Nucleus Software Exports Ltd part of regulatory sandbox programme :RBI

The Reserve Bank of India named two startups in the first cohort on retail digital payments as a part of its regulatory sandbox programme. The initial two are National Support Consultancy Services from Jaipur and Nucleus Software Exports, based in Noida. Names of 4 more companies to be announced shortly.

# 25. Lakshmi Vilas Bank Under Reserve Bank of India Moratorium, To Be Merged With DBS India

In view of its weak financials, the Reserve Bank has placed the Lakshmi Vilas Bank Limited under moratorium. All cash withdrawals from the bank have been capped to Rs.25,000. RBI also drafted a scheme of amalgamation for LVB with the DBS Bank of India. T N Manoharan appointed as administrator of LVB for moratorium.



# 26. Yes Bank launches co-branded prepaid card with Neokred for cashless payments

To facilitate cashless payments, Yes Bank launched a co-branded prepaid card in partnership with Neokred Technologies. The card offerings can be personalised to suit the requirements of corporates seeking salary cards or expense cards for their employees. Neokred Technology founder & Chief Business Officer: Rohith Reji

## 27. Karnataka Bank launches Current & Savings Account campaign of FY 2020-21

Karnataka Bank launched CASA (current account, savings account) mobilisation campaign. With this, it intends to mobilize more than 4,10,000 CASA with an accretion of Rs 650cr of business by active involvement of its 8000 + workforce in all 859 branches. It will be operational till March 4, 2021.

# 28. Mastercard, USAID join hands for Project Kirana to empower women through financial inclusion

Mastercard joined hands with the United States Agency for International Development (USAID for Project Kirana that will help increase revenue streams, expand financial inclusion & digital payments adoption of kirana shops that are owned/operated by women. 2-yr Project Kirana will be implemented in select cities of UP.

### 29. RBI panel proposes to raise promoters cap to 26% in private banks

An internal working group set up by the RBI has proposed to raise the cap on promoters' stake in private banks from the current 15 % to 26 % in 15 years & minimum initial capital requirement for licensing new banks to be enhanced from ₹500 cr to ₹1,000 cr. Scheduled commercial banks are those included in RBI Act 1934.

# 30. RBI imposes over Rs 5.78 crore fine on six entities including PNB, Sodexo, PhonePe

RBI has imposed a total fine of over Rs 5.78 crore on 6 entities, including PNB, Sodexo & PhonePe, for violating regulatory guidelines in exercise of powers vested under Section 30 of the Payment and Settlement Systems Act, 2007. Prepaid payment instruments are licensed & regulated by RBI.

# 31. RBI imposes fine on Muthoot Finance, Manappuram Finance for non-compliance

RBI has imposed a penalty of Rs 10 lakh on Muthoot Finance, Ernakulam, for non-compliance with directions on maintaining loan to value ratio in gold loans and a penalty of Rs 5 lakh on Manappuram Finance, Thrissur Section 45I of the Reserve Bank of India Act, 1934 defines NBFC

## 32. RBI becomes first central bank in the world to reach 1 mn followers on Twitter

The Reserve Bank of India has reached one million followers on Twitter. With this, the central bank of India is now the first-ever such bank in the world to have reached these many followers in the micro-blogging site. The 85-year-old RBI got a Twitter account in January 2012.

### 33. Stashfin partners Visa to launch co-branded cards with credit lines

Singapore-based Stashfin has partnered with Visa to launch co-branded prepaid cards with credit lines, amid a growing propensity towards digital payments. Cards can be used at both physical merchant locations and ATMs as well as in online modes. The prepaid card acts like a personal overdraft facility.



## 34. NSDL Payments Bank Joins Hands with HDFC ERGO to Offer Customised Insurance Solutions to Customers

HDFC ERGO General Insurance & NSDL Payments Bank announced their partnership to offer general insurance products to bank's customers & bring together distribution network of NSDL Payments Bank & HDFC ERGO to contribute towards financial inclusion in nation National Securities Depository Limited Founded: **8 August 1996** 

## 35. Home Ministry relaxes account norms for NGOs under the Foreign Contribution Regulation Act

Union Home Ministry relaxed norms for NGOs mandated to maintain FCRA account with SBI. Ministry has set deadline of 31.03.2021 for NGOs registered under FCRA to open account at SBI. It allowed NGOs to maintain existing FCRA Account for utilization purposes FCRA, 2010 come into force on 1st May, 2011

### 36. Govt approves merger of Lakshmi Vilas Bank with DBS India

The government approved the merger of crisis-ridden Lakshmi Vilas Bank (LVB) with DBS Bank India Ltd (DBIL) and removed restrictions on withdrawal of deposits. LVB is the second private sector bank after Yes Bank, has run into rough weather during this year. Lakshmi Vilas Bank Formed: 1926; HQ: Chennai

### 37. RBI rejects Muthoot Finance's proposal to buy IDBI MF

Muthoot Finance request for a NoC for its proposed acquisition of IDBI Mutual Fund was not acceded by RBI on ground that activity of sponsoring a Mutual Fund or owning an Asset Management Company is not in consonance with the activity of an operating NBFC. Muthoot Finance Founded: 1939; HQs: Kochi.

## 38. SEBI launches SMARTs program to strengthen investor education framework


# 41. RBI advises Lakshmi Vilas Bank to fully write down tier-2 bonds before DBS merger

Lakshmi Vilas Bank informed the exchanges that RBI advised the bank to fully write down ₹318 crore of its tier-2 bonds before the amalgamation with Singapore-based DBS Bank. A full-write down implies that investors in these bonds will not receive anything. DBS Bank CEO: Piyush Gupta.



### 42. HDFC Bank m-cap surges past Rs 8 lakh crore mark

The market capitalisation of HDFC Bank went past Rs 8 lakh crore making it the first domestic lender to achieve the feat. The market valuation rose to Rs 8,05,742 crore on BSE. HDFC Bank is 3rd most valued domestic firm in terms of market capitalisation. Reliance Industries is India's most valued firm.





### **Economy**

### 1. Remittances to India to drop by 9% in 2020: World Bank report

India followed by China, Mexico, Philippines, & Egypt continue to be the top 5 in 2020 to receive foreign remittances, WB said .Remittances to India would fall this year to \$76 billion due to the ongoing Covid-19 pandemic & global economic recession. Remittance flows to LMICs are projected to fall by 7%.

### 2. GST collection touches 8 month high of over Rs One lakh crore in October

Goods and Services Tax Collections in October stood at Rs 1.05 Lakh crore, crossing for the first time Rs 1 Lakh Crore mark since February this year. Out of gross GST CGST - ₹19,193 crore; SGST - ₹ 5,411 crore; IGST - ₹ 52,540 crore. Cess is ₹ 8,011 crore. The revenue for October is 10% higher than that of September.

## 3. Fitch Solutions Revises India's Fiscal Deficit Forecast To 7.8% From 8.2% Earlier For FY21

Fitch Solutions revised its forecast for central government's fiscal deficit for FY 2020-21 to 7.8% from its earlier projection of 8.2%. Fiscal revenue forecast in FY21 for central govt has been revised to 18.2% decline from the earlier forecast of 18.4%. Fiscal deficit - Difference between total income & expenditure.

#### 4. Saudi PIF to invest \$1.3 billion in Reliance Retail for 2.04% stake

Saudi Arabia's Public Investment Fund (PIF) is investing Rs 9,555 crore (\$1.3 billion) to pick 2.04% stake in Mukesh Ambani's Reliance Retail Ventures Ltd (RRVL), becoming the latest high-profile global fund to purchase a stake in India's largest retailer. It is largest investment in RRVL so far eclipsing Silver Lake.

### 5. Q2 GDP to shrink 8.6%; India to enter recession for 1st time: RBI Official

As per RBI official, GDP is likely to contract by 8.6% for the July-September period, which means India will enter into a recession for 1st time in history in 1st half of this fiscal with 2 successive quarters of negative growth due to COVID-19 pandemic. RBI Estimated: Economy will contract by 9.5% for the fiscal year

### 6. Finance Minister announces 12 key stimulus measures to boost economy

Nirmala Sitharaman announced 12 key stimulus measures to boost the economy. These measures announced under Atma Nirbhar Bharat 3.0 will provide a boost to employment, agriculture, infrastructure, manufacturing, housing and R&D of Covid-19 vaccine in India. These stimulus measures cumulatively amount to 15% of the GDP.

#### 7. Retail inflation inches up to 7.61% in October

India's retail inflation remained above 7% in October for 2nd straight month. October's retail inflation of 7.61% was higher than the forecast of 7.3% in a Reuters' poll of economists. India's economy is likely to enter a technical recession for 1st time. Two consecutive guarters of contraction is termed as recession

## 8. India's gold imports drop 47 percent during April-October; fall to \$9.28 billion

Gold imports, which have a bearing on the current account deficit, declined 47.42% to \$ 9.28 billion during April-October. The decline in gold and silver imports has helped in narrowing the country's trade deficit. India is the largest importer of gold.

# 9. BSE StAR MF launches 'Corp Direct – A Direct Investment Portal for Corporates'

Leading Stock Exchange, BSE launched Corp Direct – A Direct Investment Portal for Corporates with more features which will further simplify & provide end-to-end value-



based services to the AMCs, distributors, investors, & mutual fund industry participants. Chairman of BSE: Vikramajit Sen. MD & CEO: Ashishkumar Chauhan.

### 10. Moody's ups India's growth forecast to -10.6% for FY2021

According to Moody's Investor Service forecast, India's GDP is expected to shrink by 10.6% this fiscal year raising its projection from the 11.5% contraction it had projected earlier. Moody's forecasted GDP for FY 2021-22 to 10.8% from 10.6% earlier. Barclays expects GDP to shrink 6.4% this fiscal.

# 11. Oxford Economics revises downwards its India growth forecast; pegs at average 4.5% for 2020-25

Forecasting firm Oxford Economics predicts that India's post-COVID-19 scars could be among the worst in the world. It expects India's growth equilibrium to worsen substantially over the medium term, with potential growth averaging just 4.5% over 2020-2025. Fiscal deficit is also expected to widen 7% of GDP in 2020-21.

# 12. India's GDP Q2 2020: Economic contraction narrows to 7.5% from 23.9% in Q1

India's GDP contracted by 7.5 percent in the second quarter, from July to September of 2020-21. According to the Ministry of Statistics and Programme Implementation, Gross Value Added (GVA) came in at minus 7 percent. GDP = consumption+government spending+Investment+net exports.

# 13. Total foreign direct investment inflows into India during second quarter of financial year 2020-21 is 28,102 million dollars



## 1. Govt clears ₹10,211-crore Dam rehab project with World Bank, AIIB's assistance

The Central govt gave nod for Phase II & III of Dam Rehabilitation and Improvement Project (DRIP) to improve the safety & operational performance of selected 736 dams across India. Project worth ₹10,211 crore will be implemented from April 2021-March 2031. Share of external funding is ₹7,000 crore of total project cost

## 2. AYUSH Ministry and Invest India to jointly set up "Strategic Policy & Facilitation Bureau"

Ministry of AYUSH & M/s Invest India to form a collaboration to set up a Strategic Policy & Facilitation Bureau to facilitate planned & systematic growth of Ayush sector. Invest India to collaborate extensively to frame the plan of Bureau & define targets. Union Minister of AYUSH – Shripad Yesso Naik.

### 3. FIP organises virtual version of Delhi Book Fair this year

The Federation of Indian Publishers (FIP) organised a virtual version of the Delhi Book Fair, the oldest book fair of India after Kolkata, this year in light of the pandemic. The book fair organised in partnership with PragatiE is a two-day online event. CM of New Delhi: Arvind Kejriwal.

### 4. AAI hands over Lucknow airport to Adani group on lease for 50 years

Airports Authority of India handed over the Lucknow airport to Adani group on lease for a period of 50 years. Central government in Feb 2019 privatised 6 major airports of the nation- Lucknow, Ahmedabad, Jaipur, Mangaluru, Thiruvananthapuram, and Guwahati. Airports Authority of India HQs: New Delhi; Founded: 1995.

# 5. Centre releases Rs 2,200 cr as first installment to 15 states for improvement of air quality

Central govt based on the recommendations of the 15th Finance Commission released ₹2,200 crores as the 1st instalment to 15 states for improvement of air quality measures in their million-plus cities. Maharashtra received the highest amount of ₹ 396.5 cr. Chairman of 15th Finance Commission: N K Singh.

# 7. President Kovind promulgates Arbitration and Conciliation (Amendment) Ordinance, 2020

The Ordinance aims to ensure that all the stakeholders get an opportunity to seek unconditional stay of enforcement of arbitral awards where the underlying arbitration agreement or contract or making of the arbitral award are induced by fraud or corruption Ordinance to be promulgated only when parliament not in session

### 8. Hardeep Singh Puri Launches Nurturing Neighbourhoods Challenge

Minister for HUA Hardeep Singh Puri launched Nurturing Neighbourhoods Challenge, under which cities will be provided technical assistance and capacity-building to reimagine parks and create accessible, safe, walkable streets for children and families. He also launched Data Maturity Assessment Framework (DMAF).



# 9. Vice President launches 'International Satavadhanam' event, a unique literary feat at Tirupati, Andhra Pradesh




#### 15. PM Narendra Modi chairs 33rd PRAGATI interaction

### **Science & Technology**

### 1. IISc, Bengaluru & IOCL sign MoU for hydrogen-generation technology

IISc & IOCL signed the MOU to develop & demonstrate biomass gasification-based hydrogen generation technology for producing fuel cell-grade hydrogen at an affordable price. The technology is crucial for the fuel cell operated buses being conceived by IOCL. IOCL had launched trials of 50 hydrogen-CNG fuel buses in Delhi.

#### 2. India test-fires air launched version of BrahMos supersonic cruise missile

BrahMos supersonic cruise missile was test fired from a Sukhoi fighter aircraft in the Bay of Bengal. In 2019 May, the Indian Air Force for the first time had successfully test fired the aerial version of the BrahMos missile from a Su-30 MKI fighter aircra Also, INS Kora test fired Anti-Ship Missile in Bay of Bengal.

# 3. Metallic asteroid 16 Psyche that orbits between Mars and Jupiter is worth \$10,000 quadrillion

An extremely rare metallic asteroid has an estimated worth of \$10,000 quadrillion - more than Earth's entire economy. It is one of the most massive objects in the main asteroid belt & orbits between Mars and Jupiter about 230 million miles from Earth. It measures about 140 miles in diameter, made of iron & nickel.

### 4. ISRO to launch India's earth observation, nine customer satellites

PSLV in its 51st mission (PSLV-C49) will launch EOS-01, the primary satellite, along with 9 customer satellites owned by the US, Luxembourg & Lithuania. It will be launched from Sriharikota space port. It is ISRO's first satellite launch amid the pandemic. EOS-01 - for agriculture, forestry& disaster management support

### 5. US drug maker Pfizer's CoVID vaccine found more than 90% effective

US drug-maker Pfizer released preliminary data from late-stage human trials of Covid-19 vaccine BNT162b2, it developed with German biotech firm BioNTech. It is found more than 90% effective. It is headed for a review by the US Food and Drug Administration. Pfizer CEO: Albert Bourla. HQ: New York, USA.

#### 6. China launches 'world's first 6G experiment satellite'

China has sent into space the world's first 6G experiment satellite. The 6G satellite was among three Chinese satellites successfully launched into orbit, along with 10 commercial remote sensing satellites developed by Argentinian company Satellogic. This was the 351st rocket of China's Long March series.

### 7. Virgin Hyperloop completes first-ever human trial in hyperloop pod in US

Virgin Hyperloop completed the human trial in the hyperloop pod at the DevLoop test facility. Hyperloop is a next-generation travel system that uses pods travelling at high speeds through low-pressure tubes erected on columns using magnetic levitation. Virgin Group Founder: Richard Branson.

# 8. Fast Radio burst (FRB) spotted by NASA for the first time in Milky Way Galaxy

The X-ray portion of the simultaneous bursts was detected by several satellites FRBs are powerful, millisecond-duration radio waves.

PARAM-Siddhi AI supercomputer was established under the National Supercomputer Mission and will be installed in the C-DAC unit. The Top500 project tracks the most powerful supercomputers in the world and is published twice a year. Pratyush was ranked 78th. Powerful Supercomputer in world: Japanese Fugaku (442 petaflops)

### 11. L&T delivers India's first launch hardware for human space programme

Larsen & Toubro delivered the first hardware, the middle segment of the world's 3rd largest solid propellant, a rocket booster S-200 for the Gaganyaan Launch Vehicle to ISRO ahead of schedule. It was produced at L&T's Powai Aerospace Manufacturing Facility This booster segment is 8.5 metres long & weighs 5.5 tons.

# 12. India becomes 4th nation to get IMO nod for its own navigation system i.e. Indian Regional Navigation Satellite System (IRNSS)

India has become the 4th country in the world to have its independent regional navigation satellite system recognized by International Maritime Organisation (IMO) as a part of Worldwide Radio Navigation System. other three countries are US, Russia & China US: GPS Russia: GLONASS

### 13. China to launch moon probe, seeking first lunar rock retrieval since 1970s

China plans to launch an unmanned spacecraft to moon to bring lunar rocks in 1st attempt by any nation to retrieve samples from Earth's natural satellite since 1970s. It will make China 3rd nation to have retrieved lunar samples following US & Soviet Union China plans on retrieving the samples from Mars by 2030

### 14. SpaceX, NASA, ESA launch Sentinel-6 Michael Freilich mission

SpaceX, NASA, ESA successfully launched Sentinel-6 Michael Freilich mission. Sentinel-6a will be the first of two identical satellites, the second to be launched in five years, that will provide measurements of unprecedented precision until at least 2030. ### 15. IIT-Madras made an unmanned self-driving survey craft for ports

IIT-Madras researchers have made a Solar-Powered Unmanned Autonomous Survey Craft for Indian ports and inland waterways. It can undertake autonomous hydrographic and oceanographic surveys, providing real-time data transmission over long distances. It can be equipped with a 360° camera and LiDAR.

#### 16. IIT Guwahati develops free-space optical communication system

It will extend a nearly 30-year continuous dataset on sea level. Global sea level is rising approximately 0.13 inches a year.

# 21. The Bengaluru based IISc researchers develop wastewater treatment, recycling system for rural areas.


# 22. India to launch deep-sea exploration exercise, Earth Sciences dept to ally with ISRO, DRDO on mining project

Exercise is conducted as a non-contact, at sea only 2nd phase is scheduled from Nov 17 to 20 in Arabian sea.

# 2. Enhanced version of multi-barrel rocket-launcher system Pinaka Mk-1 missile successfully flight-tested in Chandipur, Odisha

Enhanced version of Pinaka Mk-1 system was taken up to achieve longer-range performance compared to the earlier design with lesser length. This will replace Pinaka Mk-1 missiles currently used by regiments of the Indian Army along with India's frontiers. Pinaka can fire a salvo of 12 rockets in a period of 44 seconds

### 3. Two-day joint coastal security exercise Sagar Kavach begins in Odisha

The exercise was launched at Paradip Coast. It is carried out jointly by Odisha & West Bengal govt. More than 10 departments, including Navy, Coast Guard, the Odisha Police, the local fishermen, the forest department & port marine department have joined. Paradip Coast is located in Odisha.

#### 4. India conducts major tri-service exercise in Andaman & Nicobar Islands

A special tri-service combat exercise called 'Bullet Strike' was conducted at the Teressa Island in the Nicobar group of islands. The high-voltage exercise, with assets and manpower from the Army, Navy and IAF as well as Para-SF and marine commandos. ANC was India's first theatre command established in 2001.

### 5. Rajnath Singh unveils model of Anti-Satellite Missile at DRDO Bhawan

A model of Anti Satellite (A-SAT) Missile installed inside DRDO Bhawan was unveiled by Defence Min Rajnath Singh. Mission Shakti was India's 1st ASAT Missile Test. This made India 4th nation in the world with capability to defend its assets in outer space. Mission Shakti was conducted in 2019 on Abdul Kalam Islands.

### 6. Navy's fifth Scorpene class submarine 'Vagir' launched at Mazagon Dock

Union Min Shripad Naik launched the 5th Scorpene class submarine Vagir of Project 75 in Arabian Waters at Mazagon Dock in Mumbai. Vagir is a part of 6 Kalvari-class submarines being built in India. They are designed by French Naval Defence company DCNS. Vagir is named after a sandfish, a predator of Indian Ocean.

# 7. India Successfully Test-Fires Quick Reaction Surface to Air Missile, Hits Pilotless Target Aircraft

India successfully test-fired the all-weather Quick Reaction Surface to Air Missile (QRSAM) air defence system. It was tested from the Balasore flight test range. QRSAM is capable of providing air defence on the move and has a range of 30 km. The first trial of the QRSAM was conducted on 4 June 2017.

#### 8. Second phase of Malabar Exercise begins in Northern Arabian Sea


