Instructions to candidates:

- 1. The above result is purely provisional and PFRDA reserves the right to rectify any inadvertent errors at a later stage.
- 2. The information pertaining to individual scores, cut-offs etc. shall be made available to the candidates on the website of PFRDA, shortly. RTI applications/ appeals seeking information pertaining to individual scores, cut-offs etc. shall be entertained only after "Statement of Marks" are released by PFRDA. In event of 2 candidates scoring the cut-off marks, both the candidates have been issued offer of appointment.
- 3. The appointment of the selected candidates is subject to satisfying the age limit, educational qualification, experience, other eligibility criteria as mentioned in the advertisement and also subject to police verification, Caste Certificate/ Disability Certificate/ Income and Asset Certificate verification, Medical Fitness, etc.,
- 4. The Authority reserves the right to cross check any document submitted by the candidates in support of their eligibility. If at any stage, it is found that any information furnished in the ONLINE application/ documents submitted by the candidates is/are false/incorrect or if according to the Authority, the candidate does not satisfy the eligibility criteria for the post, his/ her candidature will be cancelled and he/ she can be removed from service without notice, if he/ she has already joined the Authority without any compensation.



- 5. The selection is subject to production and verification of requisite documents complete in all respect to the satisfaction of the PFRDA.
- * Candidates selected under EWS category should note that their appointment will be provisional and subject to the Income and asset certificate being verified through the proper channels and if the verification reveals that their claim to belong to EWS is fake/false the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Bhartiya Nyaya Sanhita, 2023 for production of fake/false certificate.
